A Message from Dr. Katie Jenner

It's pretty incredible the momentum at the community level to partner together to increase career exploration, engagement, and experiential opportunities for students. Regardless if a student plans to seek employment, enrollment, or enlistment leading to service, many Indiana schools are increasingly providing career exploration and engagement in elementary and middle school and experiences in high school. This focus in K-12 is supporting students in finding their purpose and developing their best path. Below are just a few examples (of many), just in the past couple weeks...

This momentum took center stage recently as the Indiana Chamber hosted their first-ever Work-Based Learning IMPACT Summit. I saw quite a few of you at this convening, as it brought together leaders in K-12, higher education, and the workforce to discuss best practices and how we can continue to increase opportunities allowing students to have relevant exposure to the world of work. This event sought to inspire local innovation in work-based learning and also spotlight [examples of students, educators, and schools across Indiana](#) who are *already employing innovative solutions* to meet demands.

Also, just last week Indiana hosted a convening of stakeholders from across the country, focused on providing direct pathways to credential completion and access to high-quality work-based learning in high



school. Indiana's Earn and Learn Convening, hosted by [Ascend Indiana](#) and the [Brookings Institution](#), brought together leaders from Indiana, Alabama, and Colorado – states that are at the forefront of increasing work-based learning opportunities – to learn from one another about their challenges, successes, and the opportunity ahead.

One final example, you never know who you might run into at the Statehouse...and this was a happen-chance meeting that made my day! I happened to run into students and administrators from [Daleville Community Schools](#) recently during a job shadow experience for students interested in law and politics! Daleville is one district hard at work ensuring their 11th and 12th grade students have relevant work-based learning, job shadowing, and internship opportunities. In fact, they report 98% of these students were placed in work experiences last year! Under the direction of **Superintendent Greg Roach** and junior-senior high school **Principal Eric Douglas**, Daleville has secured partnerships with over 60 area employers!



In addition, the district has formed relationships with three area higher education institutions, and next year will offer the [Indiana College Core](#). Through the Indiana College Core, students will have an opportunity to earn the equivalent of one year of college before ever graduating high school.

In addition to the benefits shared above, we know that work-based learning allows students to develop a variety of skills (e.g., communication, collaboration, work ethic) within the work experience, and in some cases, can even help students understand that the path they originally chose *may not be the best fit for them (...or maybe it is!)*. As educators, we see firsthand that when students are able to explore, engage, and experience careers, they begin to develop a sense of purpose and to understand what is possible.

Thank you to our educators and administrators who are hard at work to form relationships that keep paying dividends. By engaging community partners and blurring the lines between K-12, higher education, and the workforce, we can keep moving the needle for our students. As always, thank you for all that you do!

NEW: IREAD-3 Spring 2023 Results Available in Centralized Reporting System (CRS)

Student results for the IREAD-3 Spring 2023 administration are available in [CRS](#). Individual student scores may be shared immediately with students, families, and teachers. Letters to families for [grade two](#) and [grade three](#) students are available on the Indiana Assessment Portal. As a reminder, scores go through quality checks and will be considered final on Friday, April 21. Aggregate scores (e.g., total percent of students who passed) should not be shared publicly (e.g., on school websites) until IDOE releases this data. Results for students testing via paper-and-pencil will populate within CRS on a rolling basis as paper materials are received by the scoring vendor. Only grade three students enrolled during the IREAD-3 testing window are included in the pass rate calculation, which will become available following the summer retest. This calculation will include summer retesters and current grade three students who passed in grade two. Contact IDOE's [Office of Student Assessment](#) with any questions.

NEW: IREAD-3 Paper Materials Return Deadline is Today, Friday, March 24

All paper test books must be shipped to Data Recognition Corporation by today, Friday, March 24, for responses to be scored. NEW: SAT School Day Primary Testing Window Results Now Available for Students

Students who participated in the SAT School Day primary testing window from Wednesday, March 1, through Friday, March 3, may access their scores through their individual College Board student account. To access results, students may [create a College Board account](#) if they do not already have one. Students who participate in April makeup testing may access results on Wednesday, May 3. Educators will receive access to scores for both test administrations on Friday, May 19. Note that some scores may be released later due to participation in the accommodated testing window or investigation of a testing irregularity that requires resolution. NEW: SAT School Day Makeup Testing Window Preparation

Students who were unable to test during the primary testing window or experienced a testing irregularity and are eligible to retest should participate in the makeup testing window.

- SAT Online Makeup Testing: Wednesday, April 12, through Friday, April 14, and Tuesday, April 18, and Wednesday, April 19
- SAT Paper-and-Pencil Makeup Testing: Wednesday, April 12

Schools must print new student test tickets for the makeup testing window and conduct a new preadministration session before or immediately after testing. Accommodations must also be reconfigured within the Test Information Distribution Engine (TIDE) for students, as applicable. IDOE has populated all cohort 2024 students within TIDE for the makeup testing window, and schools must determine locally which students are eligible for participation.
