A Message from Dr. Katie Jenner

For many students (and educators!), the countdown is on. The regular academic year will be wrapping up in just a few short weeks, and while everyone is looking forward to some time off, summer is also the perfect time for students to continue their learning!

Thanks to the dedication of educators and community partners, there are numerous opportunities across the state for students to enhance their learning in literacy, math, and college and career readiness during the summer months...whether that includes tutoring through [Indiana Learns](#), programming through the [Student Learning Recovery Grant program](#), or another local opportunity!

Today, I'd like to highlight one specific opportunity available to Indiana high school students statewide. For the third consecutive summer, high schools across the state are partnering with our IDOE team, CHE, GWC, and higher education institutions to help more students earn a credential of value. Research shows that increased levels of educational attainment positively impact students' future quality of life, health, living wage, employment, and sustained earning.

If you aren't familiar with **Crossing the Finish Line**, here's what you need to know:



- Eligible students can receive **free tuition and books** at Ivy Tech or Vincennes University (fees are also covered!)
- To qualify, students must be *just a few credits away* from earning the [Indiana College Core](#) or another **high-value credential** (associate degree, technical certificate, or another short- or longer-term credential).
- Over the past two years, **nearly 5,200 high school students** have participated, earning **nearly 2,100 total credential completions** and saving **over \$3.9 million** in tuition, fees, and textbook costs.
- In 2022 alone, **over 335 Indiana high schools** participated!
- **Classes begin in June**, so thank you for continuing to work with Ivy Tech/Vincennes to help your students get started today!

To date, **over 2,500 students** have already registered for classes this summer...and this number continues to grow by the day! Here's a look at the **top 10 schools** across the state with students participating, in proportion to their overall student population.

NEW: Unknown Cohort Status Check

The 2023 cohort lock is fast approaching. Please check cohort reports and pay special attention to any students with an Unknown Cohort status. The Unknown Cohort status is a dropout status and counts against the grad rate. Many of the Unknown Cohort statuses can be fixed by the school/corporation via data entries. NEW: IREAD-3 Spring 2023 Results Now Available

Score results for the IREAD-3 Spring 2023 test administration are finalized within the Centralized Reporting System (CRS). Pass percentages (and other aggregated data) will be released publicly following the summer retesting window. This release will include final results from both spring and summer test administrations. Internal aggregate scores (e.g., total percent of students who passed) should not be shared publicly (e.g., on school websites) until IDOE releases this data. Reference [pass percentage calculations guidance](#) for more information. The 2023 School Tech Plan Survey is now open through next Friday, May 5, to be completed by all Indiana school corporations, charter schools, and optionally for non-public schools. Completion of this survey is a requirement for all public schools to qualify for the connectivity formula grant, the common school fund, and grants from IDOE's Office of Academics. NEW: American Rescue Plan-Homeless Children and Youth (ARP-HCY) Remaining Balance

As the second anniversary of the \$800M set-aside from ARP Elementary and Secondary School Emergency Relief (ESSER) Fund for Homeless Children and Youth approaches, please remember:

- Funds appropriated under the ARP-HCY I & II will be available for obligation until September 30, 2024.
- The deadline for drawdown of the obligated ARP-HCY I & II funds is 120 days, or January 30, 2025 (see 2 C.F.R. § 200.344(b)).
- As of January 25, 2023, Indiana shows an available ARP-HCY balance of \$11,230,750.17, which is 86% of the total Indiana's ARP Homeless I and II allocations combined.
- Indiana school districts must report your expenditures monthly in order for IDOE to maintain accurate reporting of dollars spent and dollars available.

REMINDER FROM INDIANA FAMILY AND SOCIAL SERVICES ADMINISTRATION (FSSA): Pandemic Electronic Benefit Transfer (PEBT) Eligibility

Families who meet certain income requirements and have chosen home or virtual school for their children due to the COVID-19 pandemic may be eligible for PEBT (federal food assistance), but they must act quickly. Families must apply for this benefit before Monday, May 15. Families who meet the qualifications below are encouraged to visit FSSA's [PEBT webpage](#) to apply. (Scroll down the page to find the green button to apply.) The PEBT Home or Virtual School Program provides benefits for:

- Students in kindergarten through grade two
 - Who are attending home or virtual school for COVID-related reasons
 - Who are determined to be eligible for free/reduced price meals due to their family's income
- Students in grades three through 12
 - Who were enrolled at an NSLP (free/reduced lunch) eligible school and switched to home/virtual school after the Federal Public Health Emergency began on January 27, 2020, and

- Who are attending home or virtual school for COVID-related reasons
- Who are determined to be eligible for free/reduced price meals due to their family's income
