NEW: ILEARN Biology & U.S. Government End-of-Course Assessment (ECA) Spring Testing Window Closes Today, Friday, May 19

The ILEARN Biology and U.S. Government ECA Spring 2023 test administration closes today, Friday, May 19, for all students. Schools must also ensure that all paper test books are shipped to Data Recognition Corporation (DRC) for scoring. Preliminary results are populating within the Centralized Reporting System (CRS), and Individual Student Reports (ISRs) should be shared with students and families in a timely manner. NEW: ILEARN Rescore Request Window Now Open

The [Rescore Request Window](#) allows students and their families to meet and request a rescore for open-ended ILEARN 3-8 and ILEARN Biology ECA test items. Schools must manage this process locally, ensuring parents are notified of student results and presented with this legislatively-required opportunity, noting that rescore requests may result in an increased, decreased, or unchanged scale score. NEW: Fall 2023 PSAT/NMSQT Administration Guidance

IDOE provides funds for grade 10 and 11 students to participate in the [fall 2023 administration of the PSAT/NMSQT](#). This year, the PSAT/NMSQT will be administered in College Board's new digital format. The PSAT/NMSQT will be offered during an expanded testing window from Monday, October 9, through Friday, October 27, allowing schools greater flexibility in scheduling their testing. REMINDER: ILEARN Blueprint Committee Applications Close Today, Friday, May 19

IDOE's Office of Student Assessment is seeking educators/instructional coaches, special populations educators (special education and English learners), and curriculum-focused administrators for the upcoming ILEARN Blueprint Committees. ILEARN blueprints will be updated to include streamlined standards and assessment redesign features. There will be one committee for English/language arts (ELA) and another for mathematics. Participants focusing on mathematics will meet on Wednesday, June 14, and those focusing on ELA will meet on Thursday, June 15, for in-person meetings in Indianapolis. REMINDER: Summer 2023 IREAD-3 Retest Window Opens Monday, May 22

Students in grades three and above who still require a passing score for IREAD-3 should participate in the summer retest window, open Monday, May 22, through Friday, June 30. Schools are encouraged to work with parents when scheduling the retest for students. Corporation Test Coordinators (CTCs) must ensure that all Test Administrators (TAs) have the appropriate materials the day of testing, including the [IREAD-3 Test Administrator's Manual \(TAM\)](#) and Secure Segment 1 Script for all students. TAs must use the IREAD-3 Read Aloud Scripts for fixed-form paper-and-pencil assessments for any students whose formal plan requires a human reader and paper test. These scripts are available in the CTC's Secure Inbox in the Test Information Distribution Engine (TIDE). Review the [IREAD-3 Frequently Asked Questions](#) (FAQ) prior to administration and contact IDOE's [Office of Student Assessment](#) with any questions.

REMINDER: Literacy Remediation and Support for Students Who Did Not Pass IREAD-3

IDOE strongly encourages corporations to consider summer remediation programs for grade two and grade three students who did not pass IREAD-3 during the spring administration. Students who did not pass IREAD-3 this spring should receive additional support on foundational reading skills and reading comprehension to ensure lifelong access to other content prior to consideration for Good Cause Exemptions. REMINDER: Annual Principal Survey Regarding Initial Educator License Holders

Indiana Code 20-28-11.5-9 requires a principal at each school corporation, charter school, and virtual school to complete an annual survey for any teacher employed in the building who was *initially licensed in Indiana during the previous two years*. The purpose of the survey is to assess the quality of preparation provided by the Indiana educator preparation program the teacher completed for licensure. A survey is not required for those who completed an out-of-state program for initial licensure. More information and the 2023 survey can be accessed [here](#). REMINDER: Indiana STEM Educator Expansion Program (I-STEM) Registration Now Available

IDOE is partnering with Educational Service Centers (ESCs) of Indiana to launch the I-STEM partnership. I-STEM provides support for both currently licensed teachers in non-STEM areas and prospective teachers who are not licensed and hold a bachelor’s degree to become licensed to teach in a STEM content area. IDOE has identified eligible STEM content areas as life science, chemistry, earth/space science, physics, physical science, computer science, technology education, and mathematics. REMINDER: Fall Average Daily Membership (ADM) Count Set to Monday, October 2

House Bill 1001 moved the fall ADM count day to October 1, or a date determined by the Indiana State Board of Education (SBOE), to align with the federal pupil enrollment count, eliminate redundant counting of students, and reduce administrative burden on schools. In response to this statutory change, SBOE has set the fall 2023 ADM count day to Monday, October 2. The Data Exchange system will begin to accept data at the beginning of the 2023-2024 school year. Schools should work to review and correct data prior to the October certification. Additionally, IDOE is moving all data certifications previously due in September to October to reduce annual data certifications to five instead of six. In Indiana, a school corporation is required to provide a kindergarten program for eligible students that are five years old on or before August 1 of the school year. However, a school corporation may enroll a student who is five by October 1, and still receive average daily membership (ADM) funding. Pursuant to Indiana Code (IC) 20-20-5.5-2(h), IDOE will conduct a statewide survey to determine what curricular materials have been adopted for teaching science, technology, engineering, and mathematics in each state-accredited school. **A designee from each public school corporation, public charter school, and state-accredited non-public school is required to complete [this survey](#) by 5 p.m. ET on Friday, June 16.** If a school corporation maintains consistent curriculum adoption across grade levels and schools within the corporation, then only a single submission for the corporation is required. REMINDER: 2023-2024 Reading Plan and Dyslexia Reporting Submissions Due Friday, June 30

511 Indiana Administrative Code (IAC) 6.2-3.1 requires all public and accredited non-public schools with students enrolled in kindergarten through grade three to complete and submit an elementary reading plan

to IDOE by close of business on Friday, June 30. IDOE's Literacy Center released the new [Reading Plan Guidance](#) to assist with this requirement.

- Accredited non-public schools will use this [form](#).

In addition to the reading plan, IC 20-35.5 requires all public schools to report dyslexia screening data from the 2022-2023 school year. Accredited non-public schools are not required to submit data, but have the option to report. Charter schools will use this [form](#) for dyslexia reporting dyslexia screening data.
