## **Commendations**

\* The office staff for the food service department was prepared and organized for the Administrative Review. The staff demonstrated the desire to run a compliant program. The kitchen, storage areas, and serving areas in all reviewed schools were very clean. The food service staff were friendly and engaging with the students. The assortment of fresh fruits and vegetables on the serving lines were colorful and appealing. At Smith Elementary there were shakers containing different seasonings for the students to use on their food. St Bartholomew used black disposable trays which popped the color of the food.

## **Technical Assistance**

- \* Signage was not posted directly on the serving line explaining to the students that they may take two vegetables and/or two fruits. Some of the students took more servings and the cashier had to remove them from their trays. The cafeteria manager immediately printed cute signs with pictures of vegetables and another of fruit with the words, "take only two" before the next group of students came for lunch.
- \* It is recommended to use clear bags for grab and go breakfasts at Taylorsville school so the students will know what they will receive and for the cashier to see that all components are served.

## Finding 9052: Day of Review portion sizes insufficient.

As observed on the Day of Review, PBJ is offered daily at lunch. According to the recipe, it should contain 4 Tablespoons (2 ounces) of peanut butter and 1 Tablespoon of jelly. It did not, it was 2 Tablespoons (1 ounce) which would provide 5 ounces per week for the meat/meat alternate instead of the 9-10 ounces that is required for the grade grouping K-8.

### **Corrective Action:**

The Food Service director explained that the cafeteria manager did not follow the recipe or procedures for making a peanut butter sandwich. They had a training session with the cafeteria manager on the day of review and the Food Service Director will discuss this issue at the next manager's meeting as well. **No further action is required.**
