#### Finding 9000: Unallowable Costs

The FSMC is charging the SFA for a bonus. The bonus is an FSMC cost, which may be covered through the calculated and charged administrative and management fees, but it cannot be passed to the school as a direct cost.

#### Corrective Action:

A bonus calculated based on percentages would not be considered a direct labor cost under the contract. For corrective action, the SFA must restore the \$5,459.48 to the Nonprofit School Food Service Account with nonfederal funds for the unallowable cost charged. For corrective action, submit/upload documentation of the fund transfer to the SFA food service account.
