Finding 9000: Technical Assistance

### **Technical Assistance:**

When electronic applications are filed, do not write the yearly income total at the bottom of the page.

128. Correct conversion factors used for applications with more than one income frequency?

### Finding 9019: Incorrect conversion factors used when processing applications.

A sample of 525 applications were reviewed. Of those reviewed applications, one error was found. For an income application with only one income frequency, the SFA converted income to yearly. Converting income to annual when only one frequency is listed can make a difference in eligibility.

### **Corrective Action:**

For income applications with only one income frequency, SFA should not convert to yearly. (i.e. If only one income is listed as weekly, SFA should process application as weekly.)
