Technical Assistance - Coding of Categorical Eligible Students

Students should be coded appropriately on the Free and Reduced roster based on their most recent eligibility reason.

138. *Updates to the Benefits Issuance documents are made accurately and timely*

Technical Assistance - Effective Date on Eligibility Status

The effective date of a student's eligibility on the Free and Reduced roster should be the most recent date an eligibility change was made. For example, verified applications that result in a status change should have an effective date reflecting the date the change was made.

Technical Assistance - Converting Income for Verification

It is not necessary to convert income provided in verification documentation to a year-to-date weekly average.

Technical Assistance - Use of Collateral Contacts in Verification

A collateral contact is a person outside of the household who is knowledgeable about the household's circumstances and can confirm a household's income level or participation in Assistance Programs or Other Source Categorical Eligibility Programs. Collateral contacts could include employers, social service agencies, migrant workers' agencies, and religious or civic organizations. The verifying official should request a collateral contact only in cases when the household has not been able to provide adequate written evidence.

705. SFA have internal controls to ensure only allowable costs charged?

Technical Assistance - Documentation of Labor Costs

Some staff have dual jobs within the North Spencer County School Corporation. If staff perform work outside the School Nutrition Program, the sponsor needs to track the labor for the School Nutrition Program directly (i.e., complete it by time log). Without this type of documentation, labor would not be an allowable direct expense.

766. Assessing Compliance with the Nonprogram Foods Revenue/Cost Ratio

Finding 10141: Assessment of Non-Program Foods Revenue/Cost Ratio

The SFA did assess its compliance with the revenue from non-program foods requirements 7 CFR 210.14(f). However, the assessment did not include the following:

- a) All schools were not included in the calculation.
- b) The cost of the adult meals included entitlement discounts, indicating the full market value was not used.

Corrective Action:

The SFA must assess compliance with the revenue from non-program foods. **For corrective action, the SFA must complete the 5-day reference period using the non-program food revenue tool. Please submit the non-program food revenue tool with documentation to support the figures used.**

- a) Description of Program Overview and Facility
- b) Food service operations within the SFA
- c) Type(s) of facility
- d) Average Daily Participation for programs being operated
- e) Standard Operating Procedures: Has written procedures that are specific to each site

Corrective Action:

For corrective action, please complete the following:

- a) **Review and update the food safety plan. Submit the updated plan to the State agency.**
- b) **Provide staff with food safety plan training. Submit proof that training has been completed.**

Meal Counting & Claiming - David Turnham Ed Center (7753)

322. Review Period- daily meal counts by category do not exceed the number of eligible students by category

Technical Assistance - Monthly Eligibles

The total number of eligible students by category was not correctly reported on the claim for reimbursement. When completing the eligibles section for claims, please use the highest number of enrolled students in each category (Free, Reduced, Paid). During the onsite review, the school nutrition program assistant updated the claim for reimbursement to reflect the highest eligibles by category.

General Program Compliance - David Turnham Ed Center (7753)

1409. On-site or off-site storage violations were observed

Technical Assistance - Food Storage and Date Marking

Canned items in the dry storage area were observed to be inconsistently date marked. The SFA must ensure that all facilities for the handling, storage, and distribution of purchased and donated foods are properly safeguarded against theft, spoilage, and other loss. Additionally, proper date marking assists in ensuring the First In, First Out (FIFO) inventory management method is being used.
