## Finding 9117: Unallowable general expenses charged to the nonprofit school food service account.

Based on the SFA's accounting records for the most recently completed program year, general expenses charged to the nonprofit school foodservice account were not reasonable, necessary and/or allocable. Unallowable expenses: bad debt encumbered from unpaid student meal accounts was not covered by a transfer from the general fund.

### **Corrective Action:**

The bad debt from the unpaid student meal accounts from school year 17-18 must be paid to the foodservice account from the general fund by the end of school year 18-19. Please provide an updated written procedure for how and when bad debt will be covered by non-Federal revenues going forward.

### **Meal Components & Quantities - Sunman Elementary School (7211)**

410. Review period menus and production records - Quantities and meal pattern requirements met?

### Finding 9076: Planned menus served during Review month do not meet portion size/quantity requirements.

Production records were reviewed for the Review Period to determine whether the portion sizes of meal components from the planned menu and served during the Review Period meet the minimum meal pattern requirements for the age/grade group K-5 being served. Meals served with insufficient portion size or insufficient quantities of meal components are incomplete and may not be reimbursable. A peanut butter sandwich was offered daily consisting of 2 Tablespoons of peanut butter, which credited as 1.00 ounce/equivalents of meat/meat alternate. This would cause the weekly meat/meat alternate quantity to be insufficient.

#### **Corrective Action:**

The Food Service Director immediately sent an email to all cafeteria managers to offer a 1 ounce cheese stick with the peanut butter sandwich, this will meet the weekly meat/meat alternate requirement. No further action required.
