774. Verification of Indirect Cost Documentation

Indirect Cost Technical Assistance

The SFA should keep full records on how the Indirect Cost basis was determined and the calculations showing the allowable IC. If using a FSMC with a fixed price contract, the SFA should get some type of percentage of the fixed price contract that can be used to calculate the portion of the contract that is used for labor, in order to be able to use labor in the calculation.

Internal Control Procedures Technical Assistance

Due to your last audit, the state agency wanted to remind the SFA to always have internal control procedures in place to ensure that if ever Child Nutrition funds (i.e., student prepaid accounts, for a la carte items) are received, they are deposited into an account. Documentation would then need to be kept on file that would support this deposit.
