Commendations

- * The food service staff did a terrific job planning, organizing, and preparing for their 2023 Administrative Review. Staff were very professional and conscientious about meeting the School Nutrition Program Requirements.
- * Kitchens were clean and staff were personable, well-trained, and performed their duties with a great attitude. Batch cooking was taking place, which allows for a fresher meal for students.
- * A wonderful variety of fresh fruits and vegetables. Staff took the time to cut up and prepackage items for easy serving and consumption such as the cut-up oranges bagged individually.
- * Staff were date marking when product was cut up or served along with an expiration date including marking on boxes of grains and chips the expiration date. They placed "use first" stickers on products to ensure they were accurately rotating first in and first out procedures.
- * Even though they are short staffed, they did a great job in seeing that students move quickly through the line. The help of teachers and other staff members assisted in making sure the students quickly made decisions on making a reimbursable meal. The staff were then in the back making sure they had restocked the line for the next group coming in.

Technical Assistance

- * The date on the verification letter should be the date that denial starts if information is not received.
- * When conducting the on-site monitoring at each school, it is important for the manager or site supervisor to sign off on the report as receiving it even if no corrective action is required.

Finding 9000: Hearing Official name and contact not listed on letter.

The official verification notification letter did not have the hearing official name and contact information on the letter.

Corrective Action:

The Food Service Director updated the saved letter with the hearing official contact information. If implemented as discussed and corrected on-site, no further action is required.

Technical Assistance:

The reviewer discussed with the food service director that the verification results letter must list the hearing officials name separate from the person processing the verification procedures. It allows the parent to contact someone not involved in the verification process.

Some of the information gathered on the Off-site Assessment Tool regarding the SFA's Local School Wellness Policy could not be validated during on-site observations. Deficiencies found on-site: The current Wellness Policy is missing two goals for Nutrition Education and Physical Education.
