## Other Federal Programs - Childplace North (Z142)

7. Site monitored in first 4 weeks of operation, date, deficiencies/CA?

Finding 9228: The SFA has not monitored this site's Afterschool Snack Program within the first 4 weeks of operation each year.

The monitoring within the first 4 weeks was not completed, but they did do one in December.

#### **Corrective Action:**

Must complete two ASSP monitorings annually, one in the first 4 weeks of operation per program year and another sometime during the year. Sponsor agrees to this schedule, and if completed as stated, no further action required.

## **Meal Components & Quantities - Childplace North (Z142)**

410. Review Period- planned menu quantities meet the meal pattern requirements

#### Finding 9000: Insufficient portion size for the meat/meat alternate group at lunch

1 oz of meat/meat alternate was provided for the grilled cheese meal and the peanut butter meal.

#### **Corrective Action:**

A cheese stick 1 oz serving will accompany the grilled cheese and the peanut butter meals to equal the 2 oz requirement.
