Technical Assistance - Production Record Keeping

Technical Assistance:

Several times during the review month, the vegetables on the production record did not list the correct number of leftovers. Leftovers were documented as zero, however, there were leftovers at the end of meal service. The leftover column is required to be filled out each day for every item. By entering zero for your leftovers each day, it appears you are running out of food and all students are not being offered all food items.

Technical Assistance - Production Record Keeping

Technical Assistance:

The number of juices served always equals the amount of reimbursable meals on the breakfast production record. It is highly unlikely that every student is taking a juice every single morning. Please ensure you are accurately completing your production record each day.

409. Review Period- all required meal components per weekly meal pattern requirements were offered and served to students

Finding 9075: Production records/supporting documentation indicate weekly meal pattern requirements for the age/grade group(s) not met.

Based on a review of production records and other supporting food crediting documentation for 1 week during the Review Period (11/14 -11/18), some meals served during the week reviewed did not meet the appropriate daily and weekly meal pattern requirements for the age/grade group(s) being served. Meals missing required meal components during the week reviewed: Breakfast meals served on November 16th and 17th, 2022 were served with only 1/2 cup of fruit. 103 breakfast meals on November 16th and 125 breakfast meals on November 17th are considered unallowable.

Corrective Action:

These meals are considered unallowable; however this deficiency is not a repeat finding. Fiscal action will not be assessed for this finding; the next instance of a meal pattern finding will warrant fiscal action. The FSD and state agency have discussed this issue - it is understood, and no further action is necessary.

Technical Assistance:

The school was provided technical assistance during the on-site visit.
