Meal Components & Quantities - Kesling Campus (4717)

404. Day of Review- signage explaining the reimbursable meal was posted near/at the beginning of the service line and did not promote water or any other beverage as an alternative to milk

Finding 9000: Technical Assistance - Signage

Technical Assistance:

At Kesling Campus, there were two signs that included outdated USDA language related the meal pattern prior to 2013. The signs state that students can receive two "sides" with a combo meal. With the changes in the meal pattern rolled out in 2012-2013, students must have the ability to select full each of the fruit and vegetable components, the sign is misleading. The SFA has covered the signs and no further action is necessary.

General Program Compliance - Kesling Campus (4717)

1409. On-site or off-site storage violations were observed

Finding 9150: Storage violations were observed.

The SFA must ensure that all of its facilities for the handling, storage, and distribution of purchased and donated foods are properly safeguarded against theft, spoilage, and other loss. There were products in the kitchen of Kesling Campus school that were removed from their original packaging and not date marked afterwards.

Corrective Action:

The state agency and SFA have discussed that all items must be date marked if removed from the original packaging. This is understood and no further action is necessary.
