## Certification and Benefit Issuance - Madison-Grant United School Corp (2825)

133. Direct Certifications were correctly certified

#### Finding 9024: Direct Certifications were not correctly certified

Direct certification documentation for selected students was reviewed for completeness and accuracy. Some "possible match" students were incorrectly directly certified for free meals.

#### **Corrective Action:**

The Food Service Director identified that she had incorrectly applied free meal benefits to several students who were identified only as "possible matches" and corrected their statuses within the benefit issuance system prior to the administrative review beginning. The proper adverse action procedure was followed to notify households affected which allowed them to submit a paper meal application prior to the new meal status taking effect. No further corrective action needed.

**Technical Assistance: Production Records & Pre-K Info** 

#### **Technical Assistance:**

While onsite, discussed with FSD that breakfast and lunch production records need to include the Pre-K serving information as well. Onsite meal observations clearly indicate that the FSD understands and is following the Preschool meal pattern correctly; however, based on production records provided, it appears that Pre-K students were offered the same breakfast items as the K-2 students. In addition, at breakfast, it is recommended to provide the Pre-K students with a variety of fruit selections, not just juice daily.
