Finding 9117: Unallowable general expenses charged to the nonprofit school food service account.

Based on the SFA's accounting records for the most recently completed program year, general expenses charged to the nonprofit school foodservice account were not reasonable, necessary and/or allocable. Unallowable expenses: bad debt encumbered from unpaid student meal accounts was not covered by a transfer from the general fund.

Corrective Action:

The bad debt from the unpaid student meal accounts from school year 17-18 must be paid to the foodservice account from the general fund by the end of school year 18-19. Please provide an updated written procedure for how and when bad debt will be covered by non-Federal revenues going forward.

410. Review period menus and production records - Quantities and meal pattern requirements met?

Finding 9076: Planned menus served during Review month do not meet portion size/quantity requirements.

Productions records were reviewed for the Review Period to determine whether the portion sizes of meal components from the planned menu and served during the Review Period meet the minimum meal pattern requirements for the age/grade group(s) being served. The minimum weekly quantity requirement for grains was not met for the K-8 grade grouping.

Corrective Action:

The menu served for the Review Period has been changed- the garlic knot served with the Ravioli Bake entrée has been changed so that the meal now provides 2.00 oz/eq, and the tostada served with the Mexican Pizza has been changed so the entrée now provides 1.00 oz/eq. No further action is required, though a repeat finding on a subsequent Administrative Review may result in fiscal action.

Meal Components & Quantities - West Newton Elementary School (5189)

403. DOR - two varieties of milk available, allowable substitutions?

Finding 9053: Milk variety not offered throughout serving period on Day of Review.

As observed on the Day of Review, at least two required milk varieties were not available during breakfast service.

Corrective Action:

Going forward, two milk varieties will be served daily for breakfast. No further action is required, though a repeat finding on a subsequent Administrative Review may result in fiscal action.

410. Review period menus and production records - Quantities and meal pattern requirements met?

Finding 9076: Planned menus served during Review month do not meet portion size/quantity requirements.

Productions records were reviewed for the Review Period to determine whether the portion sizes of meal components from the planned menu and served during the Review Period meet the minimum meal pattern requirements for the age/grade group(s) being served. The minimum weekly quantity requirement for grains was not met for the K-8 grade grouping.

Corrective Action:
