# Commendations

\* The school nutrition records were prepared and organized for the review. The Staff were friendly and demonstrated the desire to run a compliant program. The serving lines were very clean and fresh fruits and vegetables looked colorful.

#### **Technical Assistance**

- \* Although the triennial assessment for the Wellness Policy could be waived for this school year, the reviewer sent the IDOE link for the evaluation and the school is highly encouraged to evaluate the policy and post the results this year.
- \* Weights and measures were discussed for the meal pattern. Fruit, vegetable, and milk components are measured in volume, and meat/meat alternates and grains are measured in weight and credited by ounce equivalents.
- \* The reviewer approved the production record that was being used but sent the link to the Food Service Director for the IDOE production record. The Food Service Director liked it because it included the vegetable subgroups section.
- \* A cashier thought that the student needed to take two fruits or two vegetables or a fruit or vegetable for it to be a reimbursable meal. The reviewer referred to the signage and also discussed it with the Food Service Director.
