### Resource Management Comprehensive Review - Plainfield Community School Corp (3330)

770. Correct Rate/Base Calculation

#### **Technical Assistance:**

During the review of indirect cost calculations a discrepancy was noted regarding the total expenditures reported in the annual financial report versus the total expenditures reported in the school corporation's revenue and expenditure report, which was used to calculate the indirect cost base. Since the school corporation charged less than the maximum allowable amount of indirect costs, this is not a finding; however, the State Agency would like for the food service director and treasurer to review the differences and report back to the state agency with any changes necessary for the annual financial report.

### **Technical Assistance:**

The food service director is advised to customize food safety plans for each school. The director has stated that the template has been downloaded and will work with managers to update the plans.

407. Day of Review- the school has complied with the planned menu, or changes made are acceptable substitutions

#### **Technical Assistance:**

Since hot vegetables are cupped up in an opaque container, and not visible to students, consider displaying an open container of vegetables so students can see what the vegetables look like. This will likely prompt more students to select the hot vegetable since we "eat with our eyes." You could also display a full sample tray or even plate hot vegetables directly onto the trays, omitting the use of disposable containers altogether.
