410. Review Period- planned menu quantities meet the meal pattern requirements

Finding 9076: Planned menus served during Review month do not meet portion size/quantity requirements. Productions records were reviewed for the Review Period to determine whether the portion sizes of meal components from the planned menu and served during the Review Period meet the minimum meal pattern requirements for the age/grade group(s) being served. Meals served with insufficient portion size or insufficient quantities of meal components are incomplete and are not reimbursable. During the week of review, it was determined the requirements for the legume vegetable subgroup were insufficient.

Corrective Action:

The SFA has corrected the portion size when legumes are served with this menu and will now meet the meal pattern requirements. This is not a repeat finding, therefore, no fiscal action will be taken. No further action required.

Technical Assistance:

The school was provided technical assistance during the on-site visit.
