The poster is in the doorway before the serving line. This reviewer suggested to place a sign above the fruit/juice area reminding the students that they must choose at least one of these.

Meal Components & Quantities - South Dearborn High School (1179)

410. Review Period- planned menu quantities meet the meal pattern requirements

Finding 9000: The Legume Vegetable Subgroup was omitted on the deli/salad bar line

The production records for the month of review, December did not include the legume vegetable sub group for one week on the deli/salad bar line.

Corrective Action:

The cafeteria manager understands and stated that she will offer black beans or kidney beans on the salad bar weekly.

Technical Assistance:

Technical Assistance was provided on the day of review to the Cafeteria Manager and Food Service Director.

410. Review Period- planned menu quantities meet the meal pattern requirements

Finding 9000: The Red/Orange Vegetable Subgroup serving size for serving lines 1 and 2 was insufficient.

The portion size for the Red/Orange Sub Vegetable Group is 1.25 cups for the week. The production records reflected only 1 cup.

Corrective Action:

The cafeteria manager stated that she will menu the Red/Orange Vegetable Subgroup twice a week in order to meet the minimum requirement.

Technical Assistance:

Technical assistance was provided to the Cafeteria Manager and the Food Service Director on the day of review.

General Program Compliance - South Dearborn High School (1179)

1407. SFA written food safety plan is implemented

Finding 9000: The dish machine's gauge for the wash cycle was not operating.

The gauge on the dish machine was not showing the proper temperature. It was stuck on zero.

Corrective Action:

The Food Service Director and Assistant Superintendent stated that maintenance department would repair this soon.

Technical Assistance:

Technical assistance was provided.
