765. Adult Meals

Finding 9128: Meals served to adults are not priced sufficiently to cover the overall cost of the meals.

Breakfasts and lunches served to teachers, administrators, custodians and other adults are not priced so that the adult payment in combination with any per-meal revenues from other sources designated specifically for the support of adult meals (such as State or local fringe benefit or payroll funds, or funding from voluntary agencies) was sufficient to cover the overall cost of the meals. The overall cost of adult meals must include the value of any USDA Foods (entitlement and bonus) used in the preparation of the meals.

Corrective Action:

The SFA will either stop serving adult meals all together or they will cover the price by either a general fund transfer or adults paying the meals themselves. All adult meals for the school year 2019 will be deemed unallowable and the price of those meals will need to be covered through a general fund transfer. The state agency needs to see that adult meals were covered for; 116 adult meals at \$3.45 comes out to a total of \$400.20. Please provide document to show these meals were paid for from nonfederal funds.

Technical Assistance:

The nonprofit food service account cannot cover the price of adult meals.
