126. Certification: selected applications correctly approved

Finding 9901: Selected applications correctly approved

Multiple applications were certified incorrectly or utilizing incomplete information. Two income applications were approved without calculating all income.

Corrective Action:

The SFA is required to send letters home to the households to inform them that they will have a change in benefits. Notify the state agency when this is completed.
