Finding 9000: Meal Counting procedures

For the month of review, the meal counting procedures were not in compliance. Some meal counts were completed by writing down the number "10" to count ten students who had selected a reimbursable meal. Each student needs to be recorded individually at the point of service, and they cannot be counted in groups.

Corrective Action:

The SFA has changed their counting procedures. During breakfast, the SFA uses daily meal count sheets at the POS. During lunch, students are marked on a roster to signify they have selected a reimbursable meal. No further action is necessary.

The SFA is currently not tracking any of their professional standard hours. All employees within food service operations must track their professional standard hours each year.

Corrective Action:

The SFA is required to use the USDA tracking tool or create their own to prove their employees have completed their required hours. The SFA provided the state agency with the tracking tool with all current food service employees listed. No further action is necessary.

7. Site monitored in first 4 weeks of operation, date, deficiencies/CA?

Finding 9228: The SFA has not monitored this site's Afterschool Snack Program within the first 4 weeks of operation each year.

The SFA's after school snack program has not been monitored this program year. Each year, it is required that the after school snack program is monitored within the first four weeks of operation.

Corrective Action:

The SFA is required to monitor their after school snack program within the next two weeks.

The SFA monitored their snack program on February 18th, 2020; no further action is necessary. CA has been attached to the review tool.
