767. Nonprogram Revenue and Food Cost Ratio

### Technical Assistance: Nonprogram Food Revenue and A la Carte Pricing

Although a slight amount of additional revenue to comply was calculated, after a detailed review of the cost analysis of nonprogram foods, it was found that only a couple of bottled drink options are priced lower than recommended. Technical assistance was provided to the Food Service Director on increasing the a la carte pricing of those items. All other a la carte pricing is sufficient.

### **Corrective Action:**

Technical assistance was provided to the Food Service Director. The summer of 2023 was the first year that the SFA did not operate the SFSP in many years, and the outreach requirement was inadvertently overlooked. The FSD verbally acknowledged that she understood the outreach requirement and will implement moving forward. The State Agency will provide language through the Weekly Newsletter in early May for the FSD to use to meet this requirement. If implemented as agreed upon, no further corrective action is needed.

### Finding 9150: Storage violations were observed.

The SFA must ensure that all facilities for the handling, storage, and distribution of purchased and donated foods are properly safeguarded against theft, spoilage, and other loss. There was one case of flour tortillas in dry storage that was past the expiration date.

### **Corrective Action:**

The manager was provided technical assistance onsite. The product was discarded. **No further corrective action is needed.**
