#### **Technical Assistance:**

On the back of approved income applications, all income appears to be converted to annual, even when it is not required. Please check into online application processing system to see if the eligibility determination is made based on correct conversions and if conversions are only used in the eligibility determination when more than one income frequency is noted.

### 133. Direct Certifications correctly certified?

### Finding 9000: Other Finding

-One student was directly certified for free meal benefits but was given reduced benefits without documentation to show the student was ever reduced. The reason for the error could not be determined.

-Two students were incorrectly classified as homeless. The eligibility was incorrectly extended.

#### **Corrective Action:**

-The student was given the correct benefit the day of review.

-The students incorrectly certified were provided with a notice of adverse action the day of review. Additional response is not required.

### **Technical Assistance:**

Eligibility documentation requirements were discussed with the food service director the day of review.

#### Finding 9000: Other Finding

Some direct certification documentation was not kept on file (i.e., DC lookups).

#### **Corrective Action:**

Direct certification lists pulled from the state application center and lookups will be either printed or saved electronically going forward. Additional response is not required.

### **Technical Assistance:**

DC documentation requirements were discussed with the food service director the day of review.

# Finding 9000: Other Finding

The SFA initially included the cost of food in the direct cost base. This resulted in an overpayment of 49,405.37.

### **Corrective Action:**

The overcharge was paid back to the foodservice account and documented in November 2018. The corrected base is \$2,677,856.14. Going forward the following formula will be used to calculate indirect costs: Total foodservice expenses - food and equipment= direct cost base. Additional response is not required.

#### **Technical Assistance:**

The SFA was provided technical assistance regarding indirect costs well before the review to ensure the overpayment was corrected.
