## Finding 9000: Meals Provided At No Cost to Staff

Adult meals are being provided at no cost. Residential Child Care Institutions may not use federal reimbursements received for participating in USDA programs to feed adults. Therefore adult meals that are provided during the participating CNP meals must be tracked and the value of those reimbursed to the food service account.

#### **Corrective Action:**

Confirm that in the future the number of meals served to adults will be tracked daily and then a monthly invoice will be prepared showing the value of the adult meals provided and then that invoice amount will be transferred into the food service account. After a review of documentation of training information, it was noted that the Wernle employee who manages and oversees food service department has not completed any professional training hours.

## **Corrective Action:**

As part of your submitted corrective action plan, please submit a plan with the completed and/or planned 12 hours of professional standards training. Include in the plan the topics and the amount of time for each. Lastly moving forward, confirm that in the future the individual with these responsibilities will always complete the annual minimum of 12 hours of professional standards training hours.

# **Technical Assistance:**

A technical assistance was conducted with the food service staff regarding this topic during the exit conference. This individual was not available for the exit conference because of being on vacation the days of the pre-scheduled onsite review.

#### Finding 9000: Food Service Director

The individual who conducts food service director responsibilities (manages and oversees the entire food service department) does not meet or has not submitted the minimum requirements for schools that have less than 500 students.

# Other Federal Programs - Wernle Children Home, Inc. (D827)

4. Validate snack counts - snacks properly counted and claimed

## Finding 9221: Snacks are not being properly counted and claimed.

The snack counts claimed for reimbursement for the review period could not be validated. The review period validated total snack count is 1,108. The total snack claimed was 1,158. The snacks were erroneously claimed for 50 snacks on one Sunday in September 2019. Snacks cannot be claimed for reimbursement on NON SCHOOL days.

#### **Corrective Action:**

The food service staff confirmed that in the future all counts for the monthly claim will be double checked by a second person prior to submitting claim. NO FURTHER ACTION REQUIRED.

#### **Technical Assistance:**

A technical assistance was conducted while onsite regarding this finding.

409. Review Period- all required meal components per weekly meal pattern requirements were offered and served to students

## Finding 9000: Serving Juice During Breakfast

More than half the total amount of fruit served at breakfast is in the form of juice for the week reviewed. Fruit offerings must include at least 50% or more non-juice choices.

## **Corrective Action:**

The reviewer confirmed during the exit conference that in the future, no more than half the total amount of fruit served weekly will be in the form of juice. NO FURTHER ACTION REQUIRED

#### **Technical Assistance:**

A technical assistance was conducted during the exit conference regarding this finding.

410. Review Period- planned menu quantities meet the meal pattern requirements

#### Finding 9000: Insufficient Meat/Meat Alternate Offered

For the reviewed week, one lunch menu (pulled pork sandwich) served had insufficient meat/meat alternate.

## **Corrective Action:**

The reviewer confirmed while onsite that whenever the pulled pork sandwich is served, a one ounce cheese stick will also be served. NO FURTHER ACTION REQUIRED
