# Finding 9075: Production records/supporting documentation indicate weekly meal pattern requirements for the age/grade group(s) not met.

Based on a review of production records and other supporting food crediting documentation for 1 week during the Review Period Feb 24-28 2020 some meals served during the week reviewed did not meet the appropriate daily and weekly meal pattern requirements for the age/grade group(s) being served. Pizza Joes, Johnny Marzetti, chili and cheese baked potato did not have the correct crediting for meat/meat alternate as reported on meal certification.

#### **Corrective Action:**

Manager and staff using scratch cook recipes are required to take training on how to write a recipe. The Pizza Joes, Johnny Marzetti, chili and cheese baked potato recipes are to be corrected and emailed to Field Specialist. If they decide not to use these recipes, the replacement meat/meat alternate along with crediting information is to be emailed to the Field Specialist.

#### **Technical Assistance:**

The school was provided technical assistance during the on-site visit. Discussed in detail with the manager and assistant manager how to determine if enough meat/meat alternate is available in a recipe by checking the food buying guide.
