765. Adult Meals

Finding 9128: Meals served to adults are not priced sufficiently to cover the overall cost of the meals.

Breakfasts and lunches served to teachers, administrators, custodians and other adults are not priced so that the adult payment in combination with any per-meal revenues from other sources designated specifically for the support of adult meals (such as State or local fringe benefit or payroll funds, or funding from voluntary agencies) was sufficient to cover the overall cost of the meals. The overall cost of adult meals must include the value of any USDA Foods (entitlement and bonus) used in the preparation of the meals.

Corrective Action:

Adult meal prices are to be set annually based on reimbursement rates, the 7-cent certification plus the commodity value. It was published in our newsletter on several occasions that the correct price for program year 2021-2022 should be \$4.60. The school only charged adults \$3.20 so the difference must be restored to the food service account. The SFA must transfer \$712.60 to the school lunch account. The SFA will provide the deposit with the date and amount to the reviewer. On 9/14/2022 this reviewer received a copy of the check for the value of the adult meals and proof that the check was deposited into the food service account. If adult meals are calculated and charged correctly going forward, no additional action necessary.

Corrective Action:

The wellness committee will review their policy yearly. If this action is taken as discussed, no further action is required.

Finding 9143: A copy of the written food safety plan is not available at each school.

White Creek Lutheran School must have a food safety plan or HACCP.

Corrective Action:

This reviewer sent a template for a food safety plan which White Creek Lutheran School will adopt and make changes as needed for their food services. If this template is used and implemented, no further action is required.
