## **Technical Assistance-Resource Management**

\* Currently, the extra entrées, PBJ sandwiches, and milks are considered part of the reimbursable meal. If this practice changes and those items are no longer part of the reimbursable meal, their usage should be tracked as nonprogram foods and the cost for those items should be covered by White's or another nonfederal fund source, in the same way the nonprogram adult meals are currently being tracked and paid.

# Finding 9007: Meal Counting and Claiming information on the Off-site Assessment Tool not validated, or deficiencies found.

Some of the information gathered on the Off-site Assessment Tool regarding the SFA's Meal Counting & Claiming procedures could not be validated during on-site observations. See site level Finding 9066 regarding POS procedures.

# Finding 9008: Civil Rights information on the Off-site Assessment Tool not validated, or deficiencies found.

Some of the information gathered on the Off-site Assessment Tool regarding the SFA's Civil Rights procedures could not be validated during on-site observations. The White's discrimination/harassment policy needs to ensure it includes information specific to Child Nutrition Programs and include the same timeline for reporting complaints of discrimination to USDA, which is 5 days.

## **Corrective Action:**

Technical assistance was provided to the Food Service Director and White's administrative staff while onsite. As corrective action, the additional resources in the Technical Assistance section below should be reviewed and implemented to ensure the Civil Rights complaint procedure is up to date. No further corrective action needed.

Meal Counting & Claiming - White's Jr/Sr High School (8673)

318. Day of Review- each meal service line provides an accurate count by eligibility category at the point of service

# Finding 9066: Inaccurate meal counts by eligibility category at the POS.

As observed on the Day of Review, each type of meal service line does not provide an accurate count at the point of service. At breakfast, the point of service (POS) should be recorded on a proper meal count sheet, not a post-it note. At lunch, there is no point of service meal count taking place. All meal counts must be marked once a student has a complete reimbursable meal in hand, not before. In addition, the house parent's count cannot be used as the meal count. Someone must be positioned at the end of the meal service line to identify that a student has a reimbursable meal in hand, then record it on a proper meal count sheet. A reimbursable meal includes at least 3 components, one of which needs to be a fruit or vegetable serving.

## **Corrective Action:**

Technical assistance was provided onsite to the Food Service Director and White's administrative staff regarding what constitutes the proper point of service at breakfast and lunch. Several meal count sheet options were provided to the FSD & admin staff to review and determine which best fits their unique needs. Field Specialist will provide follow-up technical assistance during PY2023 to ensure the point of service has been corrected. No further corrective action needed.
