



Choice Scholarship Program Estimated Award Amounts 2026-2027 School Year

Indiana is committed to expanding access to quality educational opportunities to all Indiana students. The Choice Scholarship Program provides scholarships, commonly referred to as vouchers, to eligible students in grades K-12 to help offset the cost of tuition at non-public schools that are participating in the Choice Scholarship Program. A list of participating Choice schools can be found on the Indiana Department of Education's public [website](#).

The value of the Choice Scholarship award is the lesser of:

1. Tuition and fees reported on the Choice student's application at the Choice School; or
2. The amount listed below is based on the student's public-school corporation of legal settlement.

Period 1 final award amounts are applicable to students who have applied and been approved for Choice Scholarship applications between March 1 and September 1 of the school year and remain enrolled for the entirety of the school year at their chosen Choice school.

Period 2 final award amounts are applicable to students who have applied for a Choice Scholarship award and been approved between November 1 and January 15 of the school year.
