



Filing Tax Returns for Previous Years

Individual Scenario

If you are an individual that did not file an Indiana tax return for a previous filing year, you may owe money which could be eligible for Tax Amnesty 2026.

File a missing Indiana tax return

1. Find the missing tax return form. You can go to [DOR: Individual and Fiduciary Prior Year Forms](#) and select the appropriate tax return.
 - a. If you are missing your wage statements, contact your employer or the [IRS](#).
2. Mail the completed tax return to:
P.O. BOX 28
Indianapolis, IN, 46206-0028

Do **NOT** mail to the address listed on the form if you want to participate in Tax Amnesty 2026.

Note: If you are unable to print or have a missing return older than 2009, you can order the form from [DOR: Order Tax Forms](#).

What to do while waiting for the Indiana tax return to be processed

If you don't have an INTIME account, you will need to create one to check on the status of specific amnesty eligible liabilities.

You'll need one or more of the following to create an INTIME account:

- ID: Social Security Number (SSN) or Individual Tax Identification Number (ITIN)
- Letter from DOR with the unique letter ID (top right in the header of the letter)
 - If you don't have a letter from DOR, you can request an INTIME Welcome Letter during the login creation process.
- Amnesty Case ID from United Collection Bureau (UCB)
- Recent tax return line item
- Refund amount

Steps to create an INTIME account:

- Select "Sign Up" underneath "New to INTIME?"
- Select "Create username."
- Review the information in the panels carefully, then select "Next."
- Select customer type "Individual" then follow the additional tests provided to complete registration.

Once an account has been created, DOR will send an acknowledgement letter to the email you provided.

Next steps: participate in Tax Amnesty 2026

Participation in Tax Amnesty 2026 does not begin until July 15, 2026.

Starting July 15, 2026, here is how you can participate in Tax Amnesty 2026:

- Call UCB at 888-782-5985 to pay eligible liabilities in full or set up a payment plan
- Pay on INTIME
 - Pay eligible liabilities in full, or
 - Set up a payment plan in the amnesty panel
 - The amnesty panel can only be accessed by logged in users
- Pay in full by check – mail to:
