State filing extension due Nov. 15

The due date for the [extension of time to file](#) for Indiana's Individual Income taxes is coming up, Nov. 15. If a taxpayer was granted a federal extension of time to file (due Oct. 16), they were automatically granted an extension of time to file with Indiana. It's important to file on time to avoid late filing penalties.

State and County Income tax rate changes

[Departmental Notice #1](#) has been updated to reflect local income tax rate changes in four counties. These rate changes are for tax withholding effective Oct. 1, 2024. The changed rates are as follows:

- Decatur .0245, decreasing from .025
- Fayette .0282, increasing from .0257
- Fulton .0288, increasing from .0268
- Henry .0202, increasing from .018
