Instructions for Completing OTP-M Transaction Schedule

Indicate Name (As it Appears on Permit), Distributor's License Number, and Reporting Month/Year in the provided spaces.

Transaction Type A – Purchases/Shipments of Other Tobacco Products. Resident distributors will report all purchases of Other Tobacco Products.

Nonresident distributors will report all shipments of Other Tobacco Products into Indiana.

Any product returned to the distributor that is intended for resale should be reported as a negative transaction.

Transaction Type B – Other Tobacco Products Shipped Out of State. Resident distributors will report Other Tobacco Products that were shipped out of state.

Nonresident distributors will not use this transaction type.

Transaction Type C – Other Tobacco Products Returned to Manufacturer. Resident distributors will report Other Tobacco Products that were returned to the manufacturer.

Nonresident distributors will not use this transaction type.

Transaction Type D – Other Tobacco Products Sold to Federal Government. Report sales to the federal government located within the state of Indiana.

Transaction Type E – Tax Paid Purchases from Indiana Licensed Distributors. Resident distributors will report purchases where the seller (Indiana Licensed Distributor) paid the tax. These same purchases must also be reported under Transaction Type A.

Nonresident distributors will not use this transaction type.

Transaction Type F – Untaxed Sales to Indiana Licensed Distributors. Non-resident distributors will report shipments where the purchaser (Indiana Licensed Distributor) will pay the tax. These same shipments must also be reported under Transaction Type A.

Resident distributors will not use this transaction type.

Transaction Type G – Intrastate Sales (Indiana to Indiana). Resident distributors will report Other Tobacco Products sold to Indiana customers.

Nonresident distributors will not use this transaction type.

Itemize each transaction, by invoice, separately.

- 1. Transaction Type Indicate the transaction type being reported (A, B, C, D, E, F, or G).
- 2. Document Type Enter the appropriate code from the following list:

A = Affidavit

C = Confirmation

CM = Credit Memo

I = Invoice

O = Other

PO = Purchase Order

RG = Returned Goods Authorization

- 3. **Document Date** Indicate the date of the transaction listed on the given document.
- Document Number Indicate the document number assigned for each transaction.
- Purchased from/Sold to Company Name Provide the company name of the entity you purchased from/sold to.
- Federal Identification Number Indicate the nine-digit federal employer identification number (FEIN). If the person does not have an FEIN, then use the person's Social Security number.
- License Number Indicate the Distributor's License number
 of the entity if the transaction involved an Indiana Licensed
 Distributor.
- 8, 9, and 10. Address Indicate the location address for the entity involved in the transaction.
- 11. Wholesale Price Indicate the wholesale price listed on the document for Other Tobacco Products, except Moist Snuff, Alternative Nicotine Products, and Closed System Cartridges. "Wholesale price" means the net price shown on an invoice and at which the manufacturer of the tobacco products sells tobacco products to distributors, excluding any discount or other reduction that is not shown on the invoice.
- **12.** Number of Ounces Indicate Moist Snuff and Alternative Nicotine Products ounces listed on the document. Round ounces to the nearest hundredth of an ounce (0.00).
- **13. Wholesale Price** Indicate the wholesale price listed on the document for Closed System Cartridges.
- **14.** Total Transaction Type A Add all quantities from the "Wholesale Price" columns and the "Number of Ounces" column for Transaction Type A.
- 15. Total Transaction Type B Add all quantities from the "Wholesale Price" columns and the "Number of Ounces" column for Transaction Type B.
- **16. Total Transaction Type C** Add all quantities from the "Wholesale Price" columns and the "Number of Ounces" column for Transaction Type C.
- **17. Total Transaction Type D** Add all quantities from the "Wholesale Price" columns and the "Number of Ounces" column for Transaction Type D.
- **18. Total Transaction Type E** Add all quantities from the "Wholesale Price" columns and the "Number of Ounces" column for Transaction Type E.
- 19. Total Transaction Type F Add all quantities from the "Wholesale Price" columns and the "Number of Ounces" column for Transaction Type F.
- Total Transaction Type G Add all quantities from the "Wholesale Price" columns and the "Number of Ounces" column for Transaction Type G.
