Error Code	Message
MMREF-001	Missing or invalid SSN format
MMREF-002	StateCode cannot be null
MMREF-003	Both DeliveryAddress and LocationAddress cannot be null
MMREF-004	City cannot be null
MMREF-005	Invalid state value
MMREF-006	Missing or invalid ZIP code
MMREF-007	Invalid Zip code extension
MMREF-008	EmployeeFirstName cannot be null
MMREF-009	EmployeeLastName cannot be null
MMREF-010	StateWages cannot be null
MMREF-013	County code cannot be 00 or blank if County Tax and County Wages are greater than 0
MMREF-015	Invalid county code
MMREF-016	Returns with EIC values can no longer be filed electronically
MMREF-017	Contiguous RS records that have different SSNs
MMREF-018	RW record missing on line 3
MMREF-019	Invalid line length, line length should be 512 characters long
MMREF-020	The Canadian province specified is not valid. Valid provinces for Canada are AB, BC, MB, NB, NL, NS, NT, NU, ON, PE, QC, SK, or YT.
MMREF-021	City cannot contain any numbers

MMREF-022	Invalid record type
MMREF-023	RW record must be followed by an RS record
MMREF-024	Numeric fields can only contain values that are numbers
MMREF-025	Numeric fields can only contain values that are numbers
MMREF-026	RA record is required
MMREF-027	RT record is required
MMREF-028	RF record is required
MMREF-029	RE record is required
MMREF-030	RS Record: The Employer's 10-digit Indiana TID is invalid. A valid 10-digit TID will need to be updated in your file before resubmitting. Error Code	Message
MMREF-036	If RO record(s) exists, an RU record must also exist. If an RU record exists, at least one RO record must also exist.
