Filing an Amended Return

Receiving a Copy of Your Tax Return

In order to receive copies of your tax return you must request copies via fax at 317-232-1021.

You will need:

- Your Social Security number and/or your taxpayer identification number
- Valid mailing address

Please note you may not call in over the phone or email DOR to receive this information.

Power of Attorney Form for DOR
