INSTRUCTIONS FOR UPDATING THE RECURRING SPECIAL PROVISIONS SET

Update sets are issued and dated January 1, May 1, and September 1 of each year. The update sets are strictly for the purpose of updating the user's present Recurring Special Provisions set.

The user of the Recurring Special Provisions set must follow the instructions provided below when updating the present set with this update set.

THE USER SHALL NOT DISCARD THE ENTIRE PRESENT SET AND REPLACE IT WITH THIS UPDATE SET.

This update set is in accordance with the 1995 Standard Specifications, which took effect on JULY 1, 1995 for metric designed projects and on September 1, 1995 for all other projects. Part 2, the Special Provisions Menu, the Recurring Plan Details Menu, and Part 3, the Basis for Use, have been revised as required to reflect all changes.

ENGLISH EQUIVALENTS. All of the revised and new special provisions listed below include English system equivalents of measurable quantities. These English equivalents are always placed in parentheses immediately following the metric measure. The English equivalents are shown in the 1995 Standard Specifications, all Supplemental Specifications, and all special provisions. **Such English equivalents must be incorporated as required into modifications to recurring special provisions, and into unique special provisions.**

SPECIAL PROVISIONS MENU. The Special Provisions Menu is a listing of all special provisions included in Part 4 of the Recurring Special Provisions set. The user must replace the present menu with this updated menu. **This menu is an original print. Copies must be made to use as required to complete for specific contracts.**

RECURRING PLAN DETAILS MENU. The Recurring Plan Details Menu is a listing of all plan details included in Part 5 of the Recurring Special Provisions set. The user must place this menu immediately following the Special Provisions Menu in Part 2. Like the Special Provisions Menu, **this is an original print. Copies must be made to use as required to complete for specific contracts.**

BASIS FOR USE. The Basis for Use is a listing, in code number order, of all special provisions and plan details included in Parts 4 and 5. This listing provides the user with the necessary information to determine if a particular special provision or plan detail shall be required in a contract. **The present Basis for Use in Part 3 shall be discarded and replaced with this one.**

DISCONTINUED SPECIAL PROVISIONS. The following special provisions have been discontinued because they have been incorporated into other recurring provisions, into the Standard Specifications, or into the Supplemental Specifications. **Such special provisions shall be discarded.**
