#### Dear DUAB members:

It should be clear by now that you've been thinking about things all wrong; that you've had it all backwards. Where else has a city asked to raise taxes in hopes of stimulating economic development? Where else has any city ever been successful in attracting investment by making the economic conditions more hostile? It should go without saying that when a city like Gary--a place that needs outside investment as much or more than any city in the country--asks for and gets permission to raise taxes, that this is not perceived as an incentive; especially so when one takes into consideration the effect of the relief from the caps is much more severe for commercial property. The quickest way to rebuild the tax base is to attract large-scale commercial development. Why then does the City put so much effort into driving it away; into assuring that none of these commercial interests will ever give any serious consideration to locating in Gary?

Three years ago, when the legislation was passed that allowed for the tax rates in Gary to be brought back down to reality, and the long-promised property tax relief was seemingly so close we could taste it, the city was on the verge of disaster. But the relief never came, at least not in any meaningful way. It never came partly because this board stopped it from coming the way it was promised—the way it was legislated; the way it was intended to come. In the two years that this board has seen fit to deny this relief to the taxpayers, and instead award relief to the tax consumers: this administration in particular, the city has gone from impending disaster to total collapse. Every other community in this state has been eligible to benefit by this legislation except Gary. And what was the name again of the city that has collapsed and imploded as a result? If you have the slightest doubts about this, please take another field trip to the city. And this time, not one of those predetermined guided tours, this time let's go for the real deal!

Instead of giving the City administration relief; and let's be clear here, the administration is the sole beneficiary of this relief; maybe some consideration should be given to providing relief to the taxpayers. Where is the incentive to rebuild the tax base? Are you surprised that the only economic development this administration has to boast about this year is a Little Caesar's pizza store? Can you believe they are actually proud of this achievement? It would be comical if it weren't so damn sad. If any tax relief should be available, it should be relief to the taxpayers; the relief the Legislature already saw fit to provide. Relief to the administration is distress to everyone else.

The results of this backwards logic can be seen everywhere. It's like the end of the world up here. You may have thought that you were doing the right thing. You might have fell for their pitch. Don't worry, though, you're not the first ones to fall prey to their tricks. They're

dumb like foxes! This Gary contingent that treks down hear once or twice a year, to beg for your alms (alms granted at a direct cost to every other taxpayer and citizen); to beg for forgiveness; to make a bunch of empty promises (quite effectively so far I would add), does so to the detriment of an entire city full of people. So the relief that you award them really hasn't helped the city in the slightest. All that it has done is keep the same few fatcats in Cadillacs and fur coats. The relief that you granted to this administration helped maybe a thousand or so people, while at the same time, it hurt the other 90,000 or so other people in Gary. Don't you think that it's time to quit helping the lucky few and instead start worrying about the 90,000? This contingent before you today doesn't represent the wishes of the 90,000, they only represent their own selfish desires.

We can forgive you for making the mistakes of the past; but I don't think that anyone will be so forgiving if you do it again; if you make the same mistake three times in a row. Strong people admit their mistakes. Smart people learn from their mistakes. Wise people correct them. Be strong. Think smart. Act wisely. And don't chicken out, don't take the easy path. This is going to be a little work; but it's going to be worth it!

It has been said that there is a concern that actions taken by this board may be perceived as racist, and as such, there is some reluctance to act in the manner necessary; to make the tough call. One cannot deny that the makeup of this board is noticeably white. Due to this, you may not feel the natural connection to black people. There may be some built-in awkwardness. You may also feel that by not awarding relief to the City, you are doing something to black people that will be perceived as an aggressive action. Wrong...wrong...wrong! # Gary residents decry city's request for bailout

Richard Barnes has had it when it comes to hearing about property tax relief for his hometown of Gary, Indiana. Barnes traveled to Indianapolis Friday morning to urge members of the Indiana Distressed Unit Appeals Board not to allow Gary to collect another \$11 million in property taxes from homeowners and businesses.

"Property tax relief for the city is tax payments for residents," Barnes told the board. "The time has come to provide relief for the residents, not the government."

Barnes was among a handful of residents who oppose the DUAB granting Gary an exception to the state's property tax cap. That cap limits local governments' property tax rates. Gary is asking for a one-year tax rate of three percent, a higher rate than any other Indiana city.

Indiana voters recently approved an amendment to the state constitution that puts the property tax cap on its firmest legal footing. The amendment caps the amount of property taxes for different types of property: one percent for homeowners, two percent on rental units and three percent from businesses.

Gary officials told the panel it cannot operate its city within the confines of such caps.

If it did, the city would have about a \$30 million operating budget for a city that encompassesnearly 60square miles and has 95,000 residents.

Just a few years ago, the city's budget hovered at \$75 million budget; however, the tax caps and reductions in the amount

of tax from U.S. Steel Company - the city's largest employer -is forcing the city to make drastic cuts.

Just in the last week, the city's laid off more than 30 fire fighters and shuttered three fire stations.

Gary Mayor Rudy Clay and Controller Celita Green urged the board to allow relief for this year. Both claim Gary is doing all it can to reduce expenses and is following recommendations set forth by Public Financial Management, a Philadelphia-based firm. PFM was hired at the state's insistence to be the city's fiscal monitor.

The DUAB has already provided some tax relief for Gary last year and in 2009, but by next year, the board loses authority to provide any property tax relief.

During this final go-around, some on the DUAB wonder if Gary is doing all it can to reduce expenditures. Board member Mark GiaQuinta of Fort Wayne was shocked to learn that Gary city council members earn annual salaries of \$26,000, among the highest in the state.

He said it should be cut.

"I think it would be very beneficial to the community and to all of you personally to announce a dramatic decrease in your salaries. I just think it would be a very important thing to do," GiaQuinta said. "It's not going to change anything. It's kind of window dressing. But sometimes window dressing is important."

GiaQuinta said he's sympathic to Gary's financial woes and the unique plight of the city's history of social deterioration and industrial disinvestment. He said he doesn't believe there's another city Gary's size that's being asked to make ends meet with a \$30 million budget.

However, GiaQuinta said Gary needs to look at what more it can do to cut its budget because by next year, it will have no choice.

He and other board members urged Gary to look at transferring or consolidating some of its services for health and animal control to Lake County, Indiana.

"You're going to have to think outside the box. You're going to have to create the new paradigm because you're not going to have any choice (by next year)," GiaQuinta said.

But city officials contend the county has its own financial issues, and isn't necessarily willing to take on the added cost of shouldering services for Gary residents.

Near the end of the city's presentation, several residents had harsh words for their hometown including Jim Nowacki, a longtime critic of Gary city government.

"The reason the city can't function under the tax caps is because of waste, corruption and the scandalous abuse of the authority given to them," Nowacki said. "I want the board to understand that this (Gary) is a nonfunctioning unit of government and not grant relief. What you got here is not simply a unit of government that is in distress. You've got a unit of government that is a corrupt criminal enterprise."

The board is expected to make a decision on the city's request by March.
