Dear Board Members,

Please be advised that I am writing this letter in support of relief for the City of Gary.

I am currently employed by the Gary City Court, as the Program Director for the Drug Court. The Gary City Drug Court was established in 1996 and since its inception it has had a tremendous impact on our community. The Program has allowed countless numbers of people an opportunity to become viable members of our community. If the City of Gary does not get relief, the Drug Court Program will be in serious jeopardy.

The Drug Court Program provides a second chance to many who have the potential to get lost in the criminal justice system. This is not only a matter of saving the lives of potential clients but it is a matter of public safety.

The Gary City Drug Court Program has been nationally recognized and has been used as a model for other Indiana Drug Courts, for other states and internationally. Each component of the program is designed to strengthen the community through enriching the lives of our participants via education, treatment, and employment services. The Court also ensures that participants receive any additional services that they may require.

The Gary City Court also has a mental health component. Our Special Services Court is designed to deal with those offenders that have mental health issues. Due to the deinstitutionalization of our mental health system, this program is gravely needed. If the Court is forced to cut this aspect of its function, this will have a huge negative impact on this city. Once again, this is a public safety issue. Those mentally ill offenders will not have a safety net nor will the citizens have any mechanism to ensure compliance with treatment components. This segment of the population will not only continue to prey upon the public, whether intentionally or not, but will further strain the remaining

resources by becoming an economic burden on the criminal justice system and our community. Without the Gary City Court's Special Services Court, these folks will be warehoused within the criminal justice system resulting in no benefit to the community.

As you can see, the Gary City Court is essential to the well being of this city. In addition to the above special programs, the Court provides a minimum of 10,000 community service hours per year. The Court is active in community clean up efforts, ensuring that children have coats in the winter months, and various other activities that benefit the City of Gary.

Please consider the contents of this letter when making your decision regarding the City of Gary.





Welcome to the City Court of Gary Initially, the Gary City Court was primarily developed as a traffic court. As times have changed, the Court has had to evolve to meet the needs of the public. Since the mid 1950's, criminal and civil divisions as well as other ancillary programs have been developed and implemented.

For the year 2001, Judge Deidre Monroe and her staff of 60 employees, processed 36,602 new cases. This figure includes filings that

comprise criminal, infractions, civil and city ordinance violations. These statistics represent the largest municipal court caseload in the state of Indiana.

SECOND CHANCE DRUG COURT PROGRAM is a docket created by the Gary City Court to address cases involving individuals who are addicted to drugs. Those persons charged with non-violent criminal offenses are allowed to enter pleas of guilty. Their guilty pleas are taken under advisement for a period of one year, minimally, and the participant is required to submit to weekly drug test, court appearances, job and educational training, family counseling and any other assistance necessary to help the person maintain a drug free, crime free existence.

The Court seeks to reduce the rate of recidivism, increase the productivity of these individuals to society and themselves and effectively employ alternatives to incarceration.

PROBATION SERVICES monitor a defendant's behavior in the community and their compliance with the Court's ordered conditions and sanctions. The Probation Department is required to provide assistance as well as supervise the defendants it monitors. Further, the department submits pre-sentence investigation reports for sentencing and make recommendations where appropriate to the Court.

COMMUNITY SERVICES PROGRAM partnership with the city's General Services Department by using appropriate offenders to help clean the city.

DOMESTIC VIOLENCE COUNSELING is a service provided to court ordered defendants who primarily have been charged with domestic battery related offenses. The program offers counseling to reduce recidivism that is common among domestic violence incidences.

E.A.S.E. (Elder Abuse and Safety Education) is a program designed to address increasing incidences of crimes against our senior/elder population. The Judge and/or designated staff visit seniors at their residence and various other locations to educate and enlighten them on safety tips, signs of abuse, protection against con-artist activity and other such crimes.

"DO OR DIE" was created in 1999 to address the adult male population arrested on drug related charges. In an attempt to discourage deeper involvement with drug use and other types of antisocial behavior, this rigid program provides an alternative to such continued behavior. Modeled after the Second Chance Drug Court Program, it incorporates a strengths-based approach to speak to the challenges that face this population of young men. The program requires offenders who are tottering on the brink of career criminal behavior to complete an intense year of Court supervision. The ultimate objective is to redirect innate talent, strengths and energy into positive ventures.

MENTAL HEALTH COURT is a recent program offered to defendants who are mentally challenged. Its primary mission is work in partnership with mental health providers who assist in monitoring the special needs of defendants before the court.

PRE-TRIAL SERVICES is a division of the Court that is responsible for, but not limited to, processing persons arrested on misdemeanor charges. This department initiates an interview and background check on the defendants prior to their court appearance. The department is also responsible for ensuring bond assessment, trial dates and transportation, when appropriate, of all individuals who are categorized as an in-custody.

Dear Ms. Russo,

I am writing on behalf of the Miller Citizens Corporation, a community organization in the Miller area of Gary, which has been involved in local issues for the past 37 years and has been in the forefront of the movement to control property taxes in our city and state.

The Miller Citizens Corporation (MCC) opposes the request of the City of Gary for relief from the property tax caps legislated by the Indiana General Assembly in HB1001 of 2008. We believe it is essential that the tax caps be honored to prevent the complete evacuation of residents and businesses from our city – a process which is already well advanced.

The City of Gary has presented what they claim is a plan for coming into compliance with the caps by 2012. We have some general comments about this plan:

- -Our city has been facing property tax caps for the past five years, and during this period the city has not reduced spending. In fact, city budgets have continued to increase.
- -The city's current cost reduction plan calls for a modest decrease in spending for the coming year and postpones most of the spending cuts until 2012. We don't believe these cuts will actually be made.
- -If the city can eventually operate with the income levels projected for 2012, why wait four years for these cuts make them now.
- -When the prospect of budget cuts is discussed, the City begins with the need to cut police and fire protection, which everyone agrees are critically important. They do not talk about cutting the other 800 city employees and the contract workers who are less critical.

We do not have the manpower to analyze the budget line by line and point out all the waste and extravagance. We hope you have people on your staff that has the training and the time to perform this important task. However, we would like to discuss the subject of solid waste removal as an example.

In the recent past, garbage collection has been financed by the Gary Sanitary District (GSD) and the Civil City of Gary working together. The GSD has paid about \$2 million in tipping fees and another \$2 million in salaries for garbage collection employees, who were on the city payroll but were paid by the GSD. Purchasing and maintaining the trucks and other equipment used in garbage collection has been a function of the civil city. The garbage collection service has operated reliably for many years, until 2008, when the city claimed its employees had become undependable and garbage collection became erratic.

The City then signed a no-bid contract with Allied Waste to take over all garbage collection in Gary. Part of the cost of this contract would be paid by a user fee of \$12 per household (\$7 for seniors and the disabled). The MCC is suing the city because the fee was enacted by the appointed Sanitary District Board, not by the elected Common Council; and because the large contract with Allied Waste was not put out for open bidding. The City's Motion to Dismiss the suit has been denied and the MCC has filed a Motion for Summary Judgment..

Meanwhile, the rate being paid to Allied in the no-bid contract is \$21.17 per household per month, in contrast with a rate of \$15 per household which Allied charges for the same service in surrounding communities, like Lake Station. It looks as though the payments to Allied will total \$5,588,880 per year, with the expectation of an increase in the rate in future years. Meanwhile, 46 former garbage collection employees have ostensibly been laid off, but only 24 positions have been eliminated from the 2009 budget. This is what the City calls "reducing expenses".

There are many other areas which are worth investigation in the city budgets and the budget of the various subsidiary taxing units:

-Contract services deserve close scrutiny. Contracts to the Mayor's son for taking photos of the mayor have attracted widespread publicity. However, they represent a small portion of the total spent to hire attorneys and consultants. The city seems to have contracts with every lawyer in town. The City Attorney has a very small staff, so he contracts with private attorneys whenever legal services are needed. In addition, every board in the city has its own attorney. The Common Council has an attorney to argue with the City Attorney. The Township Advisory Board has an attorney to argue with the Attorney of the Township Trustee. The Airport Board, the Sanitary District, the Park Department, the Public Library and others all have their own attorneys, who do not appear in the salary budget but are paid with personal service contracts.

-The Common Council is another extravagance. At a time when we are supposed to be cutting budgets, our local member on the council reports that its budget increased from \$1.2 million in 2008 to \$1.3 million in 2009. The nine council members each receive salaries of \$28,000 plus benefits. They are supported by a staff of nine persons, plus an attorney. The support staff includes a video technician and assistant technician, who are also paid to fill video technician slots in the salary budgets of other departments. In addition, each council person receives a substantial discretionary budget to dispense as he/she sees fit, even making grants to friends.

The City Clerk, who is in charge of keeping records and moving paper, has 44 employees. What can they all be doing?

-Hundreds of city employees are dispersed among dozens of departments, so that residents have a hard time finding who to consult with any specific problem, as a result no one can be held accountable for anything. A thorough overhaul of the government structure is needed.

In all, the city payroll (even without the contract employees) comes to one person for every 40 adults in Gary. Our position is that this situation can no longer be tolerated.

We are rental property investors in the city of Gary, IN. We own 10 homes in the town and are facing possible bankruptcy if the tax cap is not put into effect. I'm not even talking about turning a profit, but only paying our expenses. The taxes on our properties are over 7% of the value of each home EACH YEAR. This makes it impossible to even cover the yearly expenses of maintaining these homes.

We have been working in Gary for several years now, and would like to continue to do so. Gary officials' lack of budget management is forcing us into deep financial debt – one we will not soon recover from. If they continue to ask for extensions and are granted leniency, why would the current practices ever change? We must put an end to the inefficiencies now.

We have discussed this issue with other property investment owners in Gary, and we all share the same response. We simply cannot continue to do business at this rate. When will it end???? We cannot afford another year of these high tax rates.

As is probably common, we are not willing to put this on our company letterhead for fear that our business will be further harmed.

Dear Ms. Russo and Members of the Distressed Unit Appeal Board:

I am sending you this letter to express my opposition to relief requested by the City of Gary, Indiana to the Distressed Unit Appeal Board. I am sixty-six years of age and a life time resident of Gary, Indiana.

Gary, Indiana was founded in 1906 by the United States Steel Corporation. From the moment of its inception until 2004 United States Steel Corporation was the largest single tax payer in the City of Gary and it accounted for between 35 and 50% of the total revenue of the city.

In 2004 the Indiana State Legislature, at the request of the members of the legislature from Lake County, Indiana, stripped the authority of The Calumet Township Assessor to assess the United States Steel Corporation Plant in Gary. As a result of those actions the city of Gary now receives less than 10% of its total tax revenues from the United States Steel Corporation. Naturally, this marked a shift in the tax burden to the home owners of Gary, Indiana. The home owners, through an association, lobbied for change with the State of Indiana and received a 2% tax cap on residential property.

This led to the city of Gary receiving less taxes than it had received even after the US Steel tax breaks.

Presently the Gary Works facility of the United States Steel Corporation is assessed for less value than the Ross Township Assessor believes that Southlake Mall Shopping Center in Hobart, IN should be assessed at.

Be that as it may, after initiating the 2% tax cap for residents of Lake County, the state began to expand the role of the cap to a statewide application, lower the cap, and applied caps to non-single family homeowners and commercial property.

The city of Gary has come to you seeking the ability to break this cap because of financial

distress.

However, the financial crisis of the city of Gary has many other causes. To name but a few:

1. The incredible reduction in United States Steel Corporation's taxes.

2. The continual decline in the population in the city of Gary. Gary's population peeked in the early 70's at around 180,000 and today has less than 95,000 citizens. The city's population loss is, if anything, accelerating.

3. Lack of fiscal restraint by local governmental units. Virtually every department head, and many sub-department heads, in the city of Gary has a leased car, a cell phone, and many have access to city credit cards. The city has a Office of Deputy Mayor which it does not need, the Mayor has a press secretary, the city has a Director of special events, the city has a CEO, and the city council has a staff of one person for every elected council member. These are but a few of the inefficiencies that operate in the city.

4. The city has not dealt with its population loss by taking appropriate steps to proportionally cut its employment, police department, fire department, number of parks it has in its system, and similar facilities.

5. During the 70's and 80's the city built many facilities with federal funds all of which now have to be maintained and are under utilized or non-utilized.

6. After the opening of casino boats in the city in 1995 the city used the proceeds of the casino boats to build additional facilities and upgraded some of the facilities that have been built in the 70's and 80's. All of this simply increased the maintenance budgets for the city of Gary, but created no revenue.

7. As it admitted in the presentation it made to this board, the city used casino boat monies to fill-in for loss revenues after the 2004 legislation rather than actually cutting its budget.

There could be no doubt that Gary, Indiana is a city in distress. However, suggesting that the solution is to increase tax rates is sheer folly. The underlying problem with the city of Gary is that it is losing population. Without a reversal of this trend the city of Gary will die. Anyone who thinks that breaking the tax cap will somehow reverse this trend is guilty of simple foolishness. Higher taxes on our homes, our rental properties, and our businesses, will only exasperate the problem of people leaving the city. What is needed is for the city to learn to live within its budget, for the city to learn that it is no longer a large important American city but a city in a fight for its life.

The federal funds of the 70's and 80's did not work, the casino funds of the late 90's and early 21st century did not work, increasing taxes to a higher level than the rest of the state of Indiana will not work. The city of Gary has been given ample opportunity to attempt to spend its way out of its problems and it has failed. It is time to put the city's feet to the fire and force it to take the steps that it needed to take long ago, and not continuing to spend money on pipe dreams that they believe will somehow revive their city.

For example, the city of Gary has spent millions and millions of dollars in the last thirty years trying to get the Gary Airport to be Chicago's third airport. The Gary airport has neither the land nor the resources nor the position to become chicagoland areas third airport. It does have private

Gary buys new SUV for mayor

GARY | A day after pleading with the state for a financial lifeline for his city, Gary Mayor Rudy Clay defended inking a deal for a new city-paid Hummer.

"What do you want me to do, walk around here?" Clay asked Tuesday. "I've got to have a car."

That car is a 2009 Hummer H3 purchased recently by the city, to be paid in three yearly installments totaling about \$29,970, city spokeswoman LaLosa Burns said.

On Monday, Clay and a slew of city and county officials pitched a case before the state's Distressed Unit Appeals Board to provide Gary relief from new property tax caps.

One member of that panel charged with deciding Gary's fiscal fate cast doubt Tuesday that Gary has proven its need for state help if it still is buying automobiles.

"It's disappointing to learn this the day after Mayor Clay asked the Distressed Unit board to raise the property tax caps," said Ryan Kitchell, chairman of the appeals board and director of the Indiana Office of Management and Budget. "We will only consider doing so after the city has cut all that it can. The new Hummer and testimony presented yesterday clearly show that much more spending can be cut."

More than 30 Gary residents submitted comments to the board opposing the bailout, some of which lambasted the city for funding the boxy vehicle.

One letter read: "I find it repulsive that this administration would be asking for relief while Mayor Clay continues to drive a Hummer, a noneconomical, gas-guzzling vehicle at the taxpayers' expense, which is equivalent to the CEO's of the Big Three automakers coming to Washington in their corporate jets asking Congress for a bailout."

On Monday, panel member Mark GiaQuinta, of Fort Wayne, said the letters he has seen tell him that Gary residents want to see "profound change" before the city is granted any relief from the tax caps.

"I frankly have read all I want to read about a Hummer," GiaQuinta said. "But I do think, to some degree, symbolism plays a role here."

Clay said Tuesday he felt the board was dismissing the Hummer as "a petty issue. They don't want to hear about it, and I don't blame them."

The mayor's wheels have been a hot-button topic among some residents for years since Clay rode into office in his own Hummer H3. He is reported as saying that version ran the city about \$26,000.

Though he expressed frustration in doing so, Clay defended his vehicle choice Tuesday, saying, "I put my own gas in this Hummer. It's one of the cheapest SUVs. So what's the problem?

"There's a bigger issue than the Hummer I'm driving," he said. "We've got major, major financial issues over here in Gary."

In their plea to the appeals board, Gary officials have asked for four years to cope with new tax caps, which are projected to siphon \$30.3 million from the city's 2009 budget.

"I don't want to continue to make a mountain out of a molehill," Clay said, noting that he voluntarily took a 20 percent pay cut in the midst of the city's fiscal meltdown.

Not only is his vehicle fuel efficient and requires little upkeep, Clay said, but it also saves Gary residents cash.

"We're saving taxpayers money by riding in a Hummer," he said. "I could've bought a \$50,000 Expedition

Gary buys new SUV for mayor

GARY | A day after pleading with the state for a financial lifeline for his city, Gary Mayor Rudy Clay defended inking a deal for a new city-paid Hummer.

"What do you want me to do, walk around here?" Clay asked Tuesday. "I've got to have a car."

That car is a 2009 Hummer H3 purchased recently by the city, to be paid in three yearly installments totaling about \$29,970, city spokeswoman LaLosa Burns said.

On Monday, Clay and a slew of city and county officials pitched a case before the state's Distressed Unit Appeals Board to provide Gary relief from new property tax caps.

One member of that panel charged with deciding Gary's fiscal fate cast doubt Tuesday that Gary has proven its need for state help if it still is buying automobiles.

"It's disappointing to learn this the day after Mayor Clay asked the Distressed Unit board to raise the property tax caps," said Ryan Kitchell, chairman of the appeals board and director of the Indiana Office of Management and Budget. "We will only consider doing so after the city has cut all that it can. The new Hummer and testimony presented yesterday clearly show that much more spending can be cut."

More than 30 Gary residents submitted comments to the board opposing the bailout, some of which lambasted the city for funding the boxy vehicle.

One letter read: "I find it repulsive that this administration would be asking for relief while Mayor Clay continues to drive a Hummer, a noneconomical, gas-guzzling vehicle at the taxpayers' expense, which is equivalent to the CEO's of the Big Three automakers coming to Washington in their corporate jets asking Congress for a bailout."

On Monday, panel member Mark GiaQuinta, of Fort Wayne, said the letters he has seen tell him that Gary residents want to see "profound change" before the city is granted any relief from the tax caps.

"I frankly have read all I want to read about a Hummer," GiaQuinta said. "But I do think, to some degree, symbolism plays a role here."

Quit calling it a State bailout!

And it would be a travesty if the Gary taxpayers were deprived of the benefits they would realize if this opportunity were properly acted upon. Salvation for our city can be at hand, as long as the State doesn't opt to take the easy route. They cannot become a party to the City of Gary skirting the law which was established to protect taxpayers from the very abuses which Gary taxpayers have been and will continue to be victims of. So before they enter into any arrangement by which they could be perceived to be complicit or culpable in the perpetuation of the massive fraud that; has existed, exists today, and will continue to exist in Gary, this "crime of the century in the City of the Century", they need to ensure that they have done their due diligence. Doing an audit after they've enabled the City to take more of our money is not good enough. They need to do the full examination first. Any audit must be far more intensive than simply some CPAs going over paperwork in an office down in Indy. The audit needs to also be inclusive of employee performance and department performance--most likely nonperformance in Gary's case. In simple terms, we need to know exactly what we've been getting and what we're not getting for all of the billions that go through the individuals' hands that control the City's purse strings. There are many ways which our tax dollars can be taken from us without us receiving the actual benefit for which they were designated. They can be stolen through frauds. They can simply be burned up by a bloated, nonproductive system. There are any number of ways which these funds are diverted before they reach their intended use. An incredibly small portion of the overall money that makes its way through the city provides any real benefit to the taxpayers and citizens.

Simply put, we are not getting near our money's worth. It is the job--the responsibility--of the State's Distressed Unit Appeals Board to see that we do. Please do this job for us fully, properly, intensively, and extensively.

I am a little discouraged to read today that after a DLGF audit, that they only found some questionable expenses that amount to a little over \$30,000.00. I am not a CPA, but I am sure that if I were left alone with the City's books, I could find evidence of misappropriations of millions with very little effort in very little time.

I think that what the State really needs to do is something our friends at the IRS call an "Economic Reality Audit"--except in reverse! First let me explain briefly what an Economic Reality Audit (ERA) is; when individuals that report low levels of income, yet live well beyond their means, are suspected underreporting their income, sometimes the IRS sees fit to conduct an ERA. For example; if someone has Ferraris, Cigarette boats, a million-dollar house, and travels constantly, yet

only reports \$30,000.00 per year, they would probably be a good candidate for an ERA. The IRS might ask, "How did you get all of these goodies if you aren't making any money?"

But in the case of the City of Gary, where we know for a fact that they have been receiving enormous levels of income, we need for the State to conduct this "Reverse Economic Reality Audit". They need to come and do a physical audit of the condition of the city. They need to determine why the taxpayers' funds which all have very specific earmarks, have apparently been diverted. In short, why has our city fallen apart? Why has it been let go to the point of collapse? Why should we continue to have to live like this? Why do the citizens and taxpayers suffer while the ones in charge of providing these deserved services to us continue to live high on the hog? The DUAB should ask, "Why doesn't the city have any "goodies" when they have been receiving more than enough money to purchase them?" Why don't they have anything!

We want answers! We demand answers! And until we get them, don't even consider giving them more of our money!
