This particular policy was consistent with President Obama's repeated statements encouraging American workers to accept pay reductions if such reductions would preserve the jobs of fellow workers.

Additionally, I may have been the only mayor in America to voluntarily take a 20 percent pay cut, and my cabinet heads may have been the first to work five days, while being paid for only four days, each week. Obviously, the state of Indiana found this to be a solid leadership strategy.

Furthermore, our decision to expand the outsourcing of garbage collection to eliminate an estimated \$3.1 million in escalating costs and to ensure consistent trash service made good sense. In addition, our consolidation and elimination of city departments is consistent with streamlining taking place in America's most progressive private and public institutions.

Gary's comprehensive and \*stellar\* presentation to the state's Distressed Unit Appeals Board on Jan. 5 helped to demonstrate how the imposition of recent tax legislation would devastate Gary's ability to continue to provide adequate police and fire protection, which is what the state of Indiana is currently seeking to ensure across the state. As we continue to work with the Distressed Unit Appeals Board, we look forward to learning of specific suggestions that can be implemented without eradicating Gary's ability to maintain vital services and keep its citizens safe.

We remain open to new ideas that will assist our city in receiving the regulatory relief it seeks. However, at present, we believe that among cities of comparable size, Gary is among the nation's leaders in implementing extreme cost reductions without shutting down city services.

Some have suggested that I have blamed my predecessor for much of Gary's current woes. However, the question is not one of blame but of truth. Just as President Obama already has had to remind some in Congress that when he arrived at the White House there was a huge deficit and potential financial collapse awaiting him, we have been forced to provide similar context at the local level. In Gary, my administration also inherited a fiscal ship that must be steered out of existing storms as we simultaneously navigate our way into greater prosperity.

The national media have informed us adequately of what this means for the White House, but locally one is hard-pressed to find extensive analysis of how nearly \$1.1 billion (including \$300 million of casino tax revenue) was spent before I became mayor.

Additionally, while the national debt is certainly relevant, we should be informed also as to how Gary's most recent former mayor left the city with approximately \$70 million of debt, a \$4.5 million utility bill, a \$900,000 water bill and astronomical monthly expenses, such as \$38,000 per month in cell phone bills. This is not playing the "blame game," this is providing transparency and proper context for fair analysis.

At the end of the day, a true and fully contextual review of what my administration has done will demonstrate that we have not mismanaged city finances but instead have successfully managed inherited debts, implemented historic cost-cutting and maintained city services. GARY -- Gary Sanitary District customers are questioning whether they should pay a new fee for trash collection after a judge voided a related contract with Allied Waste.

Two community groups are suggesting customers deduct that fee from their bills, calling it "illegal." Sanitary District attorney Hamilton Carmouche says nothing in the ruling voided the fee, though, and money paid to GSD?accounts will first be applied to the garbage fee.

That would leave customers with an unpaid user fee balance, Carmouche added, if GSD bills aren't paid in full.

"Then your water gets shut off," Carmouche said.

In a Lake County Superior Court ruling last week, Judge Thomas Webber called Allied Waste's contract with Gary Sanitary District "null and void." That contract effectively privatized trash collection in Gary. It was challenged in Webber's court by the Miller Citizens Corp. because there was no public bidding process.

The same resolution that authorized Allied's contract last fall also established a \$12 garbage collection fee for Gary households.

The MCC, in its original complaint, asked the judge to nullify that resolution. Instead, Webber's ruling speaks only to "any and all such contracts." Allied's contract doesn't mention the garbage fee.

Allied is still gathering garbage in the community while exploring its legal options. Mayor Rudy Clay, who is also the Sanitary District's special administrator, said the collection fee stands.

MCC president Douglas Grimes, though, said several residents have asked him whether they are still required to pay the fee. Grimes said he tells them what he would do.

"What I have suggested that people do is to deduct the garbage collection fee from their bill and pay the balance,"?Grimes said.

That, Grimes said, is because the fee is based on a voided contract.

"My view is that the people have no legal obligation to pay for services provided under a contract with the GSD that is null and void," Grimes said.

Lori Peterson of the Central District Organizing Project is giving the same advice. The Gary Sanitary District has lost credibility, she said, and people don't believe their money will be refunded if the fee is ultimately tossed. "I wouldn't trust them to hold my wallet while I went swimming,"?Peterson said.

Grimes, citing state law, said the City Council is the only body that can approve the fee. An ordinance that would have done so was introduced to the council last year, only to be withdrawn.

Carmouche, however, said Clay can enact the fee as special administrator and any customer failing to pay the fee risks a loss of services.

#### Dear DUAB Staff:

The legal advertisement below appeared in today's issue of the Post-Tribune. It is likely also in the Hammond Times. It lists several hundred properties for which the City of Gary recently purchased tax sale certificates. This publication is a necessary step for them to get title to these properties. Typical legal costs related to this process are \$500.00 or more per parcel. This does not include the actual purchase price of the certificate itself.

If the City is successful in getting title to these properties--which is almost a guarantee as they are all now past the allowable period of redemption--they will be added to the long, long list of properties already owned by the City. Of course neither these, nor any of the others they already own, are taxable. If even just a few out of these hundreds of properties which they just saw fit to buy at the last tax sale wound up paying up the delinquencies, the City would have been better off. But evidently they didn't want to take any chances that they might collect these taxes. They made absolutely sure that they couldn't collect these taxes.

How can they look you in the eye and say they have done everything possible to cut expenses while they are involved in activities like this? They should be cutting their budget to the bone--which they haven't even began to do. They should also be pursuing all possible revenue streams. Putting properties back on the tax rolls would be an obvious revenue stream to explore. Removing all possibility of collecting property taxes by purchasing properties and putting them in tax-exempt status indefinitely is of course not how you start. Shouldn't they be divesting themselves of all non-essential real property rather than aggressively acquiring more?

To: The Gary City Council and to Planning Commission, within The Department of Development and Planning

I submit to you today, that there are concerns that there will be a enormous human costs associated with this Housing Urban Development project if public rights are not afforded to poor and minority as written in U.S. Code. This can be avoided if the appropriate considerations are given to the rights of the poor. I understand the city is in the beginning stages of this planning process, and I look forward to fallowing through with offering public input, soliciting the voices of the voiceless, and when ever and wherever possible, make available to public, information and resources to help them understand what there rights are. Displacement, gentrification or "de-concentration" or in what ever terms one may choose to use, undeniably so, it poses a very high risk of homelessness when Public Laws and Environmental Justice rights are not adhered to. These vital laws being associated with the Civil Rights of all city residents may all become causalities if not considered in each phase of the planning process.

As the NWI Lead with Organizing for America, I stand prepared and eager to work with this body, and to do my part, to assure that the people's voices are heard.

The proposed Sustainable Smart Growth plan has elements to it extrapolated from the Northwest Indiana Regional Planning Commission's most recent Workgroup Visions Report, whereas that in its self remains questionable in my mind. When you look at NIRPC's consultant's final report done by (America Speaks) and paying close attention to the income ranges of the participants, you will find that the poor of this region was not fairly represented, in its very first Public Forum as many of the poor whom would have like to have attended, (mainly seniors) had no access to affordable transportation.

As this plan relates to regional reform, I caution you. Especially in the area of Public Hearings, in this plan, appearing under "Variances CZO sections 163.030 on pg.37," you will find the "Application process for public hearings. It for the most part, is procedural and sights nothing related to U.S.C public laws, or environmental justice rights being beneficial to the public. However there is loose language referencing local, state and federal laws that may be enforceable in appeals for land use however, that being up to the departments discretion, and with no bright blue line of Civil Rights language to be found afforded to the public, particularly in the Residential sections of this plan, one may find him or herself

citizens as mention above is now and has been for a large number of years, forcing our middle class citizens out of the city and has provided no opportunities for unemployed or hard-to-employ members of our community.

I ask that this board consider in its next faze, doing a comprehensive study on the causes and conditions creating the effects our citizens currently suffer under related to: the City's most recent outsourcing with private equity firms, Public Private contracts, Energy and other utility costs to its Citizenry, and the taxing burdens and costs of city services in relationship, to the current displacement of families, and family being forced from their homes.

I offer to this body to take in consideration a scholarly study done by the Colligate School of Planning that can be found in the "Journal of Planning Education and Research, Vol. 25, No. 3, 249-263 (2006)"

#### Brief Synopsys:

"During the past decade, renewed calls for central city revitalization have come from scholars and practitioners working within a new regionalist perspective. Such arguments have provided much of the ideological underpinning for coalitions around the country promoting smart growth and other regional reforms. Smart growth policies seek to curb urban sprawl by channeling investment into already developed areas, including inner-city communities. Given the attention paid to urban policy among advocates of the new regionalism, one would expect inner-city minorities to be well represented in the dialogue. However, the dialogue over smart growth and regionalism has largely failed to engage inner-city African Americans, Latinos, and other minorities. This article asks why that is the case, examines the consequences, and proposes a strategy for reframing the new regionalist debate in a way that may resonate more with minority stakeholders."

Gentrification can result from urban reinvestment efforts by local governments or neighborhood groups, which directs money to invest in deteriorating city infrastructure, offer incentives for redevelopment, improve access to housing loans for low-income or minority mortgage seekers, assist lending to first-time home purchasers, and improve rental properties. These efforts have been linked to reductions in local property crime rates, increased property prices, increased revenue to local governments from property taxes and increased tolerance of sexual minorities. Grassroots efforts taken on by existing residents to guide or oppose gentrification, generates community activism and lawsuits and in many situation exposes corruption...ie).

The process has a human cost to the neighborhood's lower-income residents. The increases in rent often result in the dispersal of communities whose members find that housing in the area is no longer affordable. Additionally, the increase in property taxes (due to increased property values) may sometimes force or give incentive for homeowners to sell their homes and move to less expensive neighborhoods. While those who view gentrification positively cite local reductions in a neighborhood's property crime rate, its critics argue that overall crime rates have not actually been reduced, but merely shifted to different lower-income neighborhoods...ie)

The U.S. Center for Disease Control and Prevention defines gentrification as "transformation of neighborhoods from low value to high value. Gentrification and neighborhood revitalization are often the

Stephanie, answer me...if I had not paid on time - my property taxes, based on the timeline that McDermott HAS NOT, for many years, who in the hell would not put it up for sale, for back-taxes. I am sickened about this. This isn't a funny joke. I want the governor himself to answer me.

I also want to know why he doesn't do a damn thing about the political "I'll scratch your back if you scratch mine" crap that goes on in Lake County. I only see another Rod Blago in McDermott, Jr. There's never enough money for his family.

I'm a person that always has been interested in politics. I used to campaign everywhere I lived, and the most honorable I served was the late Don Hart, who passed away years ago, who was the fairest of all, before passing away with Lou Gherig's disease.

I beg the governor to intercept, to have an outside investigative entiety to see for himself what is going on in Lake County...I am at my whit's end. I don't want to live in a corrupt county anymore. I don't want to be associated with Lake County, and I made sure I am not a part of Indiana...I will rent out...for various reasons...the cops are political, and incompetent. I had the house broken into, had the thief in my car, confronted the cop with the thief willing to confess, only told to "take him home, the prosecutor will call him". Meanwhile, the family moves out. All I got was what I already knew: the family left overnight a month before I wrote the letter. I was told in Sept., on the 16th, "It takes six weeks for fingerprints to come back."

Hello...that was Sept. 15th, 2008. It is now February, not a word. I wrote the police chief yesterday, no response.

Meanwhile, I get targeted for not having Indiana license plates on a snowy night at 5:30 p.m., driving to a corner store, across from the red buildings, the "project" - for not having Indiana license plates. I was sicker than a dog with the flu. My hearing aid broke the few days before. I am deaf without it. To short-circumvent the vetting process as to why someone as far away from Manhattan, IL would be shopping in the area after two squad cars pulled up, I immediately told the officer I was deaf, my hearing aid went out, I was staying temporarily with my son to help him with his taxes (who runs Bass Lake Beach and Campground), and that I was just staying with him at a certain address I recited. I did this to explain why I was in a drug-infested area,...to sick to go to a Food4Less the other way...I only needed two items. Short story long, he writes down my license number and address of Illinois, and crosses it out and put my son's local address down...and of course, I couldn't hear what he said, read the tickets when I got home.

In it he lied. He said I was parked three feet away from a curb (excuse me, next to a snowpile, and I have severe PAD, was sick with the flu, couldn't hear, etc). There was no handicapp parking required by law. There was a bus stop in front of the corner store, and since I was unable to park ahead of the owner's car to walk thru the snow, I parked, partially blocking a sidewalk no one bothers to use.

I am now stuck with going to court next Monday. Because I am deaf, even with a hearing aid, I will require a

"CART" to transpose what is being said in court. I will require a public defender. ## EDITORIAL: State takeover is needed in Gary/NWI.com

Gary Mayor Rudy Clay is appealing for outside help in rescuing his city. Stimulus money? He'll take it. State or county income tax? He'll take it.

But that's not the outside help the city needs, and it's not what the state Distressed Unit Appeals Board should do for the city.

Gary is the only city to appeal to that agency for help. That appeal was a foregone conclusion. Gary's situation was precisely why that board was set up.

A rescue plan cooked up by Democrats in the Indiana House of Representatives would steer millions of dollars to Gary.

"We cannot allow the city of Gary to go bankrupt," said state Rep. Mara Candelaria Reardon, D-Munster.

But isn't that what going before the Distressed Unit Appeals Board amounts to?

To hear Clay talk, he's looking for an irrational rescue.

"So when that stimulus money comes, we want to be the first in line," Clay said last week. "The bill passed the Senate with approximately \$5 billion coming to the state of Indiana. We're not asking for a lot of money out of that. We're only asking for \$400 million, which would create about 18,000 jobs in Gary."

That's on top of the mayor's plea last month for relief from the new state property tax caps.

"If Gary is not afforded relief from the state at this time, the city will be unable to guarantee adequate public safety since we will immediately be forced to drastically reduce the scope and size of our public safety apparatus," he said.

The city's appeal to the Distressed Unit Appeals Board not only asks permission to delay property tax caps for businesses but also presupposes a county income tax will be put in place.

Clay points out that Gary has been slashing millions of dollars in spending from the city budget. But even that isn't enough.

Gary, like its taxpayers, must be forced to live within its means. A bailout with stimulus money or a new state or county tax will not bring this necessary change soon enough.

Gov. Mitch Daniels should use the Distressed Unit Appeals Board to run the city and get its costs in line with available funds.

Why should the folks all over Indiana or all over Lake County pay to run a city that has been mismanaged for so many years?

Gary's revitalization is important for all of Northwest Indiana, but it must begin with the city coming to grips with fiscal reality. A state takeover is what the city needs most right now.



At Monday's meeting of the MCC, President Doug Grimes advised city residents not to pay for their

trash collection when they receive a bill as part of their water bill.

The private no-bid agreement between Allied Waste and the City of Gary that would result in a surcharge of \$12 a month that would be added to your regular water bill, has been declared illegal, null and void.

This means that any charges made to the residents of Gary for trash removal is also null and void. They cannot charge you for their illegal agreement.

If the City of Gary or the GSD turns off the water of any resident who protests or questions the trash collection charge by non-payment, it will be another trip to the courtroom and another law suit against the City of Gary.

The court has already ruled against the City of Gary and in favor of Gary residents. The \$5.5 million agreement between the City of Gary and Allied Waste is null and void. So is their attempt to charge us for an illegal action is also illegal.
