MFRF Time in Service Evaluation

Purpose: To establish the process of evaluating the time in service of a National Guard or Reserve service member for eligibility for use of the Military Family Relief Fund.

References:

Title 915 IAC 3

IC 10-17-12-7.5

IC 10-17-12-10

Policy: If the veteran does not have twelve (12) full months of active duty service, as proven by a DD-214, but has served in the National Guard or Reserves, the program manager shall do the following:

- Obtain a copy of the veteran's NGB-22 or NGB-23B.
- Tally the number of AD days for inactive duty training (monthly drill, annual training, special work orders, or non-Title 10 orders) days in the AD column of the form.
- The NGB-22 or NGB-23B will already have the active duty time that is noted on the DD-214, so the tally of AD days for inactive duty training should be 365 days or more.
- If the tally is not over 365 days, the veteran must provide further documentation, if applicable, to prove that they have more eligible time.
- If the tally is 365 days or more, the veteran meets the time in service requirement.
- The program manager shall include all copies of the NGB forms, along with the DD-214, in the veteran's application packet.
 - A physical copy of all forms related to this policy shall be saved for archival purposes.
 - A digital copy of all forms related to this policy shall be saved for archival purposes in the MFRF folder of the shared drive.

Effective Date: This Policy shall be in effect immediately upon approval by the Commission

Ending Date: This Policy will end upon rescission by vote of the Commission
