Indiana Invests Over \$1.25 Million to Support Veterans

The Indiana Department of Veterans Affairs (IDVA) is stepping up for veterans with a major investment of over \$1.25 million in Grants for Veterans' Services (GVS). This funding has been awarded to 32 outstanding organizations across Indiana to support programs that make a real difference for veterans and their families.

These grants will fuel critical services like preventing homelessness, offering suicide prevention programs, providing therapy, and helping veterans with job training and job searches. They'll also improve access to essential resources, ensuring veterans get the support they need to thrive.

Jake Adams, IDVA Director, emphasized the importance of this initiative:, "The GVS program provides vital financial support to empower nonprofit organizations to deliver direct and meaningful assistance to our veteran community." Adams adds, "This initiative reflects our unwavering commitment to Indiana's veterans, family members, and veteran caregivers, perfectly aligning with IDVA's mission to Support, Serve, and Advocate for Indiana's veterans."

The 32 organizations receiving these grants are deeply committed to veterans' well-being. They include groups like Armed Services Arts Partnership, Dogs Helping Heroes, Goodwill Industries of Michiana, Indiana Legal Services, and the YMCA of Greater Indianapolis, among others. Each is working to address veterans' unique needs, from mental health support to housing and employment.

Governor Braun Signs Proclamation Supporting Women Veterans

June 12, 2025

On June 12, 1948, President
Harry S. Truman signed the Women's Armed
Services Integration Act into law, a pivotal
point in American military history transpired.
This landmark legislation granted women the
right to serve as permanent, regular members
of the United States Armed Forces.

Prior to this act, women's role in the military was limited, temporary, and often auxiliary. While thousands of women served courageously during World War II—through organizations like the Women's Army Corps (WAC), Women Accepted for Volunteer Emergency Service (WAVES), and others—they did so without the benefits, recognition, or security afforded to their male counterparts. Their service ended with the war, and reentry into civilian life meant leaving behind their military identity.

President Truman's signing of the Women's Armed Services Integration Act changed that.
The Act allowed women to serve in the Army,

Navy, Marine Corps, and Air Force in both active duty and reserve capacities.

This legislation was more than an administrative change. It acknowledged women's capability, courage, and commitment, and laid the groundwork for women to serve in the U.S. military.

From a modern perspective, the Women's Armed Services Integration Act stands as a reminder of the importance of representation and institutional change. By recognizing women as essential and permanent members of the armed forces, the Act helped shift public perception and expand opportunity.

As we observe June 12th, we honor the countless women who pushed boundaries and proved, time and again, that their place in uniform was and is earned through service, sacrifice, and excellence.

Governor Braun has recognized June 12th as Women Veteran Recognition Day

and encourages all of Indiana citizens to to do the same.

Your Voice, Your Story


We invite you to share your story with IDVA and each other!

"I thoroughly enjoyed EVERYTHING about this retreat. I'm so glad you all do this for women veterans who especially need this."






