
To whom it may concern:

RE: **WARN Notice for Care Ambulance, Indianapolis Division**

Dear Indiana Department of Workforce Development,

As has been announced, Care Ambulance is closing its facility located at 1202 West 16th Street, Indianapolis, Indiana (the "Facility"). All employees at the Facility will be affected, and this closing will result in the permanent layoff of approximately 82 employees. This notice, which is a notice in compliance with the Worker Adjustment and Retraining Notification ("WARN") Act, is to formally inform you that your position will be eliminated. The information provided below represents the best information available to Care Ambulance, Indianapolis Division, at the time this notice is issued.

1. When will the layoffs begin and when am I likely to be laid off?

The expected date of layoff will be February 2, 2018.

2. Do I have any right to "bump" other employees from their jobs based on my seniority with the company?

Because this is a facility closure, there will be no bumping rights.

3. Who has been notified about this plant closing?
