



RE: Notice Pursuant to Worker Adjustment and Retraining Notification Act

Dear Sir/Madam,

This notice is being provided to you on June 1, 2017 pursuant to the Worker Adjustment and Retraining Notification Act of 1988, which requires employers to give official notice to certain government units or officials of a pending mass layoff. Cintas Corporation ("the Company") is the employer at the former G&K Services, Inc. rental facility located at 9145 East 33rd Street, Indianapolis, IN 46235 (the "Address"). Over the course of the next two months, the Company expects to terminate its workforce at the Address as a result of the permanent closure of the facility. It is anticipated that the facility operations will end on or about July 31, 2017.

The Company expects to terminate approximately sixty-nine (69) employees as a result of the plant closure. Pursuant to the Worker Adjustment and Retraining Notification Act, 29 U.S.C. §§ 2101 et seq., the Company is hereby providing you with at least sixty (60) days notice regarding this plant closure.

Terminations of the employees are expected to take place on or about July 31, 2017. There are no bumping rights available to employees. Attached to this letter as Schedule "A" are the job titles and the number of affected employees in each job classification. The Company will supplement this list should this information change in any way. The Company is providing certain benefits to certain terminated employees in accordance with the Company's benefit plans and policies. There is no union representing the affected employees.
