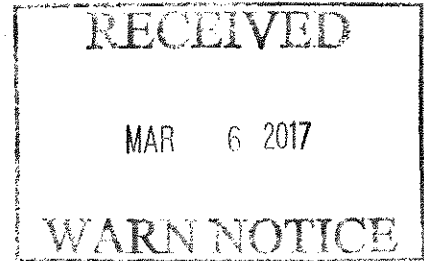

To Whom It May Concern:

As you may already be aware, Corizon Health ("Corizon") will cease providing health care services to inmates of the Indiana Department of Corrections ("IDOC") after March 31, 2017. Corizon was made aware of this decision on February 22, 2017. Due to the loss of our entire IDOC health services agreement, this action is expected to be permanent in nature and affects our employees as employment terminations of Corizon employees will occur on that date. As a result, employment with Corizon will also end on March 31, 2017 and bumping rights do not exist.

The names and addresses of the employment sites where the layoffs will occur along with the number of employees affected are enclosed with this letter.

For your information, it is our experience that in situations like this, where an employer is terminating employees because of the loss of a contract to another contractor, the new contractor often hires many of those employees, although there is no guarantee that it will do so.

If, for any reason, the last day of the contract is delayed or is otherwise modified, we will inform you once we have received official notification.

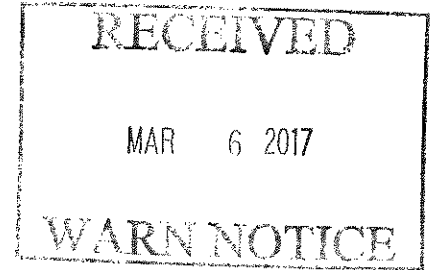

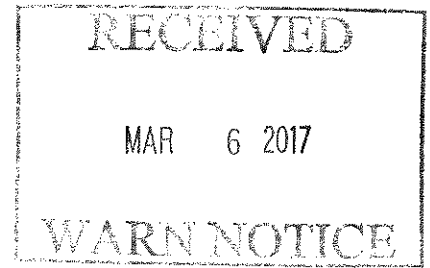
