

Dear Ms. Long:

This letter is being issued pursuant to the Worker Adjustment and Retraining Notification Act ("WARN") to notice the Department of Workforce Development, Dislocated Worker Unit that Jeffboat LLC ("Jeffboat") intends to conduct layoffs at its shipyard facility located at 1030 East Market Street, Jeffersonville, IN 47130. This action is in response to a decrease in the demand for the vessels that Jeffboat manufactures at the facility. Layoffs are expected to begin on or about November 1, 2017 and continue at a minimum through the first calendar quarter of 2018. Approximately 278 employees will be affected in total. While we do not currently intend to close the facility, we expect the separations will be permanent within the meaning of WARN.

A list of the affected job classifications and number of affected employees in each classification is attached as Exhibit A. The majority of the affected employees are represented by the General Drivers, Warehousemen and Helpers, Local Union No. 89, affiliated with the International Brotherhood of Teamsters, Chauffeurs, Warehousemen and Helpers of America ("Teamsters"). Notice regarding the layoffs has been sent to Mr. Jim Kincaid, Teamsters Local 89, 3813 Taylor Blvd., Louisville, Kentucky 40215. Bumping rights are governed by the collective bargaining agreement.
