

Re: Closure of St. Vincent Frankfort Hospital, Inc.

To Whom It May Concern:

St. Vincent Frankfort Hospital, Inc. provides you notice, pursuant to the Worker Adjustment and Retraining Notification Act of 1998, of its permanent closing and cessation of operations effective May 31, 2017. The address of this facility is 1300 South Jackson Street, Frankfort, Indiana 46041. Indiana University Health intends to take over operation of the hospital effective June 1, 2017, such that the last day of employment at St. Vincent Frankfort Hospital, Inc. for affected employees will be May 31, 2017.

Attached to this letter as Schedule A is a listing of the job positions and number of affected employees in each job classification at St. Vincent Frankfort Hospital, Inc. and those of certain contractors with employees at St. Vincent Frankfort Hospital, Inc. we felt important to include due to impact of their associates. Those contractors include St. Vincent Health, Inc., St. Vincent Medical Group, Inc., and Medxcel Facilities Management. There are no bumping rights applicable to terminated employees, and there is no union at St. Vincent Frankfort Hospital, Inc. or the other listed organizations. Affected employees have been provided with notice of this action. Affected employees may apply for other employment opportunities, and it is our understanding that Indiana University Health is communicating with the affected employees about available employment opportunities as it takes over operations.


