Re: Announcement of Upcoming Employment Terminations at Hoosier Alliance

Dear Ms. Long:

AmeriHealth Caritas Services, LLC (the “Company”) will be transitioning out of its MDwise Hoosier Alliance (“Hoosier Alliance”) business in the coming months, and MDwise, Inc. will assume responsibility for operations heretofore performed by the Company (“Transition”). As a result of this Transition, the Company will be terminating the employment of approximately ninety-five (95) Company employees working in the Hoosier Alliance unit, located at 5604 Fortune Circle South Drive in Indianapolis, Indiana starting on July 1, 2015.

It is anticipated, but not guaranteed, that MDwise will hire a significant number of AmeriHealth Caritas employees whose positions with the Company are being eliminated in the Transition. Depending on the number of employees hired by MDwise, this event may or may not constitute a “mass layoff” within the ambit of the federal Workers’ Adjustment and Retraining Notification (“WARN”) Act. Regardless, the Company has elected to provide notice of these upcoming job eliminations.

All affected employees have been notified of their separation dates and that the termination of their employment with the Company employment will be permanent.

The attached Exhibit 1 is a list of the job positions and number of individuals whose positions with the Company will be terminated.

There will not be any bumping rights for the affected employees, that is, employees will not be able to displace more junior employees out of their job positions as a result of this event.



