

Dear IDWD:

Please accept this letter as notification pursuant to the Worker Adjustment and Retraining Notification (WARN) Act of 1988, 29 U.S.C. §§ 2101, *et seq.* This letter is also being sent via overnight delivery.

After considerable review, Caremark RX, L.L.C., a subsidiary of CVS Pharmacy, Inc., (the "Company") has decided that it must permanently lay off the employees at its Coram Enteral Nutrition Center located at 7353 Company Drive, Indianapolis, IN 46237. The Company will consolidate the functions of this location into the existing Littleton, CO, and Jackson, TN locations.

Lay-offs are scheduled for February 27, 2015. There are approximately 124 employees expected to be affected by these lay-offs. Attached to this letter as Exhibit A is a list of the job titles of affected positions and the number of employees affected holding each position. Affected employees at this location do not have bumping rights, and are not represented by a union. Certain employees may be offered the opportunity to remain with the Company in other positions, although the number and identity of those employees is unknown at this time.

The information contained in this letter is also being provided to the Mayor of the City of Indianapolis, Gregory A. Ballard.


