

Re: Notice Pursuant to Federal Worker Adjustment and Retraining Notification Act

Ladies and Gentlemen:

This letter constitutes notice pursuant to the Federal Worker Adjustment and Retraining Notification Act ("WARN"), 29 U.S.C. Section 1201, et seq., and any related Department of Labor regulations that there will be a closing of the entire facility for the Integra Hospital located at 2401 W. University Avenue, #8n, Muncie, IN, 47303, Muncie, IN, the same which is operated by Renaissance Specialty Hospital of Central Indiana Operations Company, LLC dba Integra Specialty Hospital. The entire facility will be closed. We expect the primary business operations of the hospital to close on June 17, 2012. We expect this action to be permanent and to commence during this period. However, this date is subject to and may change depending upon business circumstances. This notice is intended to comply with all the requirements of WARN, although giving this notice does not constitute an acknowledgement by Renaissance of any obligations under WARN in the event the effects of the facility closing or resulting layoffs are such that WARN requirements do not apply.

The job titles and number of employees affected are set forth in the attached chart. It is anticipated that some of these employees will be offered the opportunity to transfer to other long term care facilities. None of the affected employees have "bumping rights" and the affected employees are not represented by any labor union or other representative. While we believe we have provided all information covered by the applicable regulations as required by Section 639.7(f) of the WARN Act regulations, we will maintain all other information on the layoffs which will be available upon request.
