Dear Governmental Officials:

This letter is being issued in accordance with the Worker Adjustment and Retraining Notification Act (WARN) in order to notify you that Acument Global Technologies will permanently close and lay off approximately 59 employees from its facility located at 4366 N. Old US Hwy 31, Rochester, IN 46975 beginning on October 23, 2020.
