## Dear Governmental Officials:

This letter is a follow up to a letter dated October 23, 2020 previously sent to you. Please be advised that on or around December 23, 2020, American Axle and Manufacturing will be permanently closing its facility located at 307 S. Tillotson Street, Fremont Indiana 46737. Consistent with these plans, the separations of affected employees will begin on December 23, 2020, or within two weeks thereafter. Due to a change in business needs, it is necessary that several of the employees who were previously identified as being separated on December 23, 2020, or within two weeks thereafter, be moved to a later separation date.

A revised list containing the previous date of anticipated layoff date, new layoff date, affected job titles and the number of employees per classification is attached.

All terminated employees will be paid all earned wages and agreed-upon fringe benefits upon termination. The plant closing will be permanent and will involve the entire facility. No bumping rights will exist for any employees.

We are committed to making the transition as smooth as possible for our employees, our customers and for the community.
